

Plan, organize, control and direct the delivery of comprehensive child development and care services within the Child Development Center; provide direction, organization, and support for a comprehensive ECE instructional lab program. Lead and manage employees, budgets and other resources. Ensure compliance with state, federal, and local laws, rules, and regulations. Serve as liaison to and coordinate with appropriate local, state, and federal groups and agencies.

Work load has increased, opening new 2 classrooms with a CDC capacity of 90 families.
