The U.S. Department of Education (Department) has reviewed a single audit report of Monterey Peninsula College (MPC). This audit report, prepared by Vavrinek, Trine, Day, & Co., LLP, Certified Public Accountants, in accordance with the Office of Management and Budget Circular A-133, covers the period July 1, 2011 through June 30, 2012. This letter advises MPC of the Department's final audit determination concerning the portions of the audit report that relate to the programs authorized pursuant to Title IV of the Higher Education Act of 1965, as amended, 20 U.S.C. §§ 1070 et seq. (Title IV, HEA programs).

The Department has considered the corrective action plan and/or management's response provided with the audit report. MPC's response satisfactorily addressed the auditor's finding. Any supporting documentation submitted with MPC's written response is not included with the final audit determination. However, it will be retained and available for inspection by MPC upon request. Copies of the final audit determination, MPC's response, and any supporting documentation may be subject to release under the Freedom of Information Act (FOIA) and can be provided to other oversight entities after the final audit determination is issued.

Sections .315(b) and .320(c) of OMB Circular A-133 requires MPC to prepare and submit as part of the reporting package a *Summary Schedule of Prior Audit Findings* that reports the status of prior audit findings. In preparing that Schedule, MPC must comment on all actions taken to correct the finding noted in the audit report.

Information provided by MPC and/or the auditor was sufficient to resolve the following finding:

Finding Number 2012-2 – *Inaccurate Federal Pell Grant and Direct Loan Reporting to the Common Origination and Disbursement (COD) System* – Per a phone conversation with MPC on April 29, 2013, it was confirmed that MPC corrected the disbursement dates in COD as soon as the error was discovered. In the Fall semester of 2011, the District stated that it worked with its internal Information Technology staff, and the outside software vendor to develop a solution. The solution was successfully implemented in the Spring 2012 semester. The District's financial aid coordinator can now change the disbursement dates prior to submitting the file to COD so that both records match.

MPC is advised that repeat findings in future audits or failure to satisfactorily resolve the finding of this audit may lead to an adverse administrative action. An adverse action may include the imposition of a fine, or the limitation, suspension, or termination of the eligibility of the institution pursuant to 34 C.F.R. Part 668, Subpart G.

Program records relating to the period covered by this audit must be retained until the later of: resolution of any loans, claims, or expenditures questioned in the audit, 34 C.F.R. § 668.24(e)(3)(i), or the end of the retention period applicable to the record under 34 C.F.R. §§ 668.24(e)(l) and (e)(2).

FEDERAL AWARDS FINDINGS AND QUESTIONED COSTS FOR THE YEAR ENDED JUNE 30, 2012

The following findings represent significant deficiencies, and/or instances of noncompliance including questioned costs that are required to be reported by OMB Circular A-133.

2012-1 COD REPORTING

Federal Programs Affected

Student Financial Assistance Cluster - U.S. Department of Education (DOE), Federal Pell Grant Program (CFDA No. 84.063) and Federal Direct Student Loans (CFDA No. 84.268)

Criteria or Specific Requirement

34 CFR Section 690.83: Submission of reports, Disbursements To or On Behalf of Students A-133 Compliance Supplement: Student Financial Assistance Cluster:

For Pell and Direct Loan disbursements, the disbursement date and amount in the Common Origination and Disbursement files must agree to the disbursement date and amount in students' accounts or to the amount and date the funds were otherwise made available to students.

Condition

During our review of the requirements for disbursement to or on behalf of students processed at the District, it was observed that disbursement dates and amounts reported in the Common Origination and Disbursement (COD) files did not match the District's financial records.

Questioned Costs

None noted.

Context

The condition was identified as a result of reviewing the District's compliance requirements for disbursements to or on behalf of students.

Effect

The District is not in compliance with the Federal requirements described in the A-133 Compliance Supplement.

The District can potentially face future financial sanctions or penalties from DOE if the District fails to take corrective actions to remedy the condition identified.

Cause

The District has not implemented policies and procedures to ensure compliance with Federal requirements regarding disbursement to or on behalf of students.

FEDERAL AWARDS FINDINGS AND QUESTIONED COSTS FOR THE YEAR ENDED JUNE 30, 2012

Recommendation

It is recommended that the District implement procedures to ensure that the disbursement date and amount match between the COD files and the students' account records.

Management's Response and Corrective Action Plan

This finding is a carryover from the 2010-11 audit, however, the District has recently implemented a fix. In the fall semester of 2011, the District was working with internal IT staff and the outside software vendor to develop a solution. The solution was successfully implemented in the spring 2012 semester. The District's financial aid coordinator can now change the disbursement date prior to submitting the file to COD so both records match.

2012-2 SUSPENSION AND DEBARMENT

Federal Program Affected

National Science Foundation Marine Advanced Technology Education Resource Center (CFDA No. 47.076)

Criteria or Specific Requirements

Agencies shall establish procedures for the effective use of the List of Parties Excluded from Federal Procurement or No-Procurement programs to assure that they do not expend assistance to listed parties in violation of the Executive Order.

Condition

The District is not verifying that all vendors for which the Federal grant has expended over \$25,000 has been suspended or debarred by the Federal government as required by the Office of Management and Budget.

Questioned Costs

No questioned costs. See context.

Context

The District did not expend any funds to excluded parties; however, controls are not in place to ensure that future Federal funds are not expended to an entity included in the Excluded Parties List.

Effect

Future expenditures to excluded parties can result in the District having to return Federal funds.

FEDERAL AWARDS FINDINGS AND QUESTIONED COSTS FOR THE YEAR ENDED JUNE 30, 2012

Cause

The District has not implemented a control to ensure all vendors are being verified as not being suspended or debarred.

Recommendation

We recommend the District implement procedures to verify all vendors who are providing services to federally funded programs in excess of \$25,000 are not suspended, debarred, or otherwise excluded. The District should also update contracted templates, or purchase orders, for all contract types that exceed \$25,000 to avoid any non-compliance and possible return of Federal monies.

Management's Response and Corrective Action Plan

The Fiscal Services department has implemented an internal procedure to verify all federally funded programs vendor requisitions are checked in the System for Award Management (SAM) website. This will ensure that the vendor is not suspended or debarred by the Federal government and that the vendor is not on the Excluded Parties List. This procedure was taking place, but only for the requisitions that were over \$25,000. Staff is now instructed to check all vendors who have cumulative transactions in excess of \$25,000.

The Fiscal Services department will also update the independent contractor form for the federally funded programs which will have a check box to verify that the System for Award Management (SAM) website has been reviewed and verified that the vendor is not on the Excluded Parties List.

STATE AWARDS FINDINGS AND QUESTIONED COSTS FOR THE YEAR ENDED JUNE 30, 2012

The following findings represent instances of noncompliance and/or questioned costs relating to State program laws and regulations.

2012-3 ATTENDANCE ACCOUNTING PROCEDURES

Criteria or Specific Requirement

CCR, Title 5, Section 58022, and Chapter Four of the Student Attendance Accounting Manual published by the California Community Colleges Chancellor's Office state that each course using the Actual Hours of Attendance Method that claims attendance on the Annual 320 must provide a tabulation that provides a detailed listing of actual student hours of attendance.

Condition

During the review and testing of positive attendance courses under Instructional Service Agreements and Contact Hours Recalculation we were unable to obtain source documentation that verified students attended and completed the courses to support the hours claimed on the Apportionment Attendance Report Form CCFS-320.

Questioned Costs

Unknown at this time. However, testing has revealed a total of 189 FTES related to positive attendance courses taught under Instructional Service Agreements and an additional three FTES related to other positive attendance courses for which supporting documents could not be obtained.

Recommendation

The District should closely monitor and review attendance procedures related to the execution of positive attendance courses to ensure that there is an adequate system in place to retain attendance records as source documentation to support hours claimed for apportionment.

Management's Response and Corrective Action Plan

The District has taken corrective actions to ensure that proper documentation is generated for instructional services agreements. Staff has notified program directors at the South Bay Police Academy, that paper records be retained pursuant to the adopted Records Retention board policy. Program Directors at the Fire Academy and Pacific Repertory Theater have been notified to verify their existing documentation of positive attendance by validating with daily attendance records and providing instructor certification of such. The District is looking at standardizing the use of attendance forms to improve readability of data input. Signed and authenticated positive attendance records will be retained by Admission and Records, including daily attendance and total hours.

STATE AWARDS FINDINGS AND QUESTIONED COSTS FOR THE YEAR ENDED JUNE 30, 2012

2012-4 TO BE ARRANGED (TBA) HOURS

Criteria or Specific Requirement

- California Community Colleges Chancellor's Office Legal Advisory 08-02: A clear
 description of the course, including the number of TBA hours required, must be published in
 the official general catalog or addenda thereto and in the official schedule of classes or
 addenda thereto.
- California Community Colleges Chancellor's Office Legal Advisory 08-02: Specific
 instructional activities, including those conducted during TBA hours, expected of all students
 enrolled in the course are included in the official course outline. All enrolled students are
 informed of these instructional activities and expectations for completion.
- CCR, Title 5, Section 58022, and Chapter Four of the Student Attendance Accounting Manual published by the California Community Colleges Chancellor's Office state that each course using the Actual Hours of Attendance Method that claims attendance on the Annual 320 must provide a tabulation that provides a detailed listing of actual student hours of attendance.

Condition

During testing of courses with TBA hours it was noted that there was inconsistency regarding the number of TBA hours attached to a given course when looking at the College Catalog, the Schedule of Classes, and the Course Outline of Record. Additionally, it was noted that the District is unable to provide detailed documentation that supports the completion of TBA hours by the students enrolled in the courses.

Questioned Costs

Unknown at this time. However, testing has revealed that a total of 120 contact hours claimed on the Apportionment Attendance Report Form CCFS-320 for which supporting documents could not be obtained.

Recommendation

We recommend the District modify its Course Catalog, Schedule of Classes, and Course Outlines of Record to ensure that the number of TBA hours attached to a particular course is consistently communicated within all documents. In addition, all District personnel should be made aware of the requirements for the District to maintain detailed documentation to substantiate TBA hours for reporting data on the Apportionment Attendance Report Form CCFS-320.





Colleagues,

The following are items of interest and importance for our system, and are provided for your information. If you have comments or concerns on any of these items feel free to email me at bharris@ccco.edu or telephone me at 916-322-4005.

- 1. Budget Developments: I will refrain here from going into detail about the budget since I am confident that you have all received news on the Governor's May Revision as well as the proposals by the Assembly and Senate. Needless to say, this is a far better conversation than we have had in several years and the proposed support by the Governor, Assembly and Senate is a clear demonstration of the value our state leadership places in the work you have done during the very difficult past four years. During my more than two decades in California, I have never seen a time when our system priorities of restoring access and improving student success have aligned better with those of our elected leaders. We expect an on-time budget again this year and that means the next few weeks will be critical. I have enclosed a summary of the budget points we made in the Legislature after the Governor's May Revision for your information. As you can see, both the Senate and Assembly picked up on parts of our recommendations. I encourage all of you to keep talking with your elected representatives on the tremendous needs you are facing in restoring access, rebuilding your core budgets (COLA) and improving the success of students. All of us here will be focused on the budget in the coming weeks and if in your conversations with your Assembly members and Senators you learn something you think we should know, please call me or Deputy Chancellor Skinner directly.
- 2. <u>Salary Surfer to Be Previewed This Month:</u> Later this month we will roll out a new online tool to help students explore careers and fields of study as they plan for their future. The <u>Salary Surfer</u> tool will be an online method for the public to review the aggregated median salaries of students two years before they complete a given program, degree or certificate, and compare that wage with earnings two and five years after they complete their work. I think you will find some very exciting and interesting information in this new tool, and it will again as did our scorecard allow us to tell our own story rather than be defined by our critics. I have enclosed some sample pages of the tool that will be live June 19, 2013. We will be kicking off the new tool at Grossmont College with a statewide press event on June 19th. We expect this on-line tool will generate tremendous interest. In addition to the <u>Salary Surfer</u>, enhancements to our existing DataMart tool will allow you to view some of these data for programs at the college level.



- 3. Enrollment: I know the vast majority of you have been adding summer and fall classes to your schedules as you begin to restore the access we have lost over the past few years. We all understand that each of our colleges will have differing abilities to add classes back depending on local demand in their given area. While we are in this "enrollment trough" and as we work to turn our system from rationing to restoring access, our enrollment will be less predictable and stable than normal. We expect many colleges to combine their efforts to improve students success with access restoration by offering student success courses with the added funding for additional courses. Your enrollment managers and academic leaders will have their hands full balancing student demand and available resources. Thank you in advance for what you will do to quickly and carefully restore the classes our students need to complete their educational goals.
- 4. The Foundation's Career Pathway Student Assistant Program Partnership in Workforce **Development:** As we continue to implement our approach to workforce development through our "Doing What Matters for Jobs and the Economy Program," the Foundation for California Community Colleges is partnering with us in in several ways. The Foundation has an innovative paid student internship program named the Career Pathway Student Assistant Program. This Program is a terrific fit for our Doing What Matters Program because it provides students with valuable technical and muchneeded soft skills training while removing barriers for employers who might otherwise not be interested in setting up and maintaining the back-office infrastructure necessary to implement a student internship program. The Foundation's program, not only saves employers money it also appeals to them because the Foundation handles the administrative and human resource burden normally involved in recruiting, hiring and paying college interns. The program also helps fill existing and future workforce skill gaps by creating a pipeline of well trained workers by matching paid internship opportunities for students in their fields of study. The Foundation is also continuing to explore new opportunities to work with the Chancellor's Office and interested colleges, districts and consortia in developing effective, cohesive, and scalable statewide work-based learning and job placement systems that will help meet local and regional needs. We are excited to be partnering with the Foundation in this important effort, and if you are interested, please contact Greg Thomas, the Foundation's Human Resources Director at gthomas@foundationecc.org or 916-325-1857.
- 5. Chancellor's Office Oversight-Related Issues: Since assuming this post in November I have seen numerous examples of the wonderful work our colleges are doing daily with students. I have had the opportunity to visit a dozen of our colleges and talk with many of you on system-related issues. Unfortunately, I have also had the opportunity to review several issues related to the "oversight" responsibilities of the Chancellor's Office. These issues have been related to attendance reporting, accreditation, facilities funding and several others. It is the nature of this job that we will periodically disagree with the colleges as we work to interpret – and in some cases enforce – the many laws of the state. In most of the cases I have reviewed thus far I have upheld the original decision of the Chancellor's Office and in every case the CEO involved has been very understanding although they have obviously disagreed with my decision. I want to assure you that I take each appeal of a decision made by our office very seriously, and I attempt to carefully review the claim before I make a ruling. Although my purpose here is not to encourage you to challenge the rulings of my staff who I think do a fabulous job in a terribly understaffed environment, I do want you to know that if you question our decisions your appeals will be carefully reviewed and the response will be professional and timely. Having served as you now do as a local CEO, I can understand that you may sometimes feel as if we do not listen or understand. I can assure you that is not the case and our office much prefers to tell you "yes" rather than "no." However, like all of you, we sometimes must make difficult decisions that put us at odds with the very people we are trying to support and serve. Thanks for your understanding.

California Community Colleges

Priorities for New Funding

While we are grateful for the funding proposed in the May Revision, we understand there is a possibility of even additional more resources becoming available for Proposition 98 purposes given the LAO's revenue estimates. With that in mind, we thought it would be useful to articulate funding priorities for the California Community Colleges should additional resources be provided. This document is consistent with the System Budget Request approved by the Board of Governors in the fall and is the product of collaboration between the Chancellor's Office and key system stakeholders. Thank you for considering these options.

<u>Current Year</u> — If the final budget assumes the higher revenues estimated by the LAO, the CCCs would stand to gain significant increases in one-time revenues. Assuming an 11% split of the CY P98 increase, CCCs would be in line to receive about \$99M in new funds. Also of note is that the community colleges are funded below the 11% split in the Governor's current year proposal (10.55%). The colleges would benefit from the availability of additional 1-time resources.

<u>Priorities</u> – We believe the best uses of 1-time funds are for 1-time purposes. It is ultimately unfair to use 1-time funds on items such as compensation, as there is no ongoing source to sustain the compensation into the future.

Given that, here are our top priorities for current year funds:

- Deferred maintenance (40%) The deferred maintenance program's purpose is to keep the existing community college physical plant in operational condition and to prevent any degradation in instructional services caused by facility conditions. By properly maintaining our facilities and replacing major building components at their scheduled time roofs, utilities, windows, etc. we will extend the useful life of our buildings and we can focus more of any capital outlay bond funds on meeting the system's growth needs. Nearly half of our facilities are 40 years old and our backlog of needs is close to \$1 billion.
- Instructional Equipment and Materials (40%) Currently, community colleges cannot adequately fund instructional equipment, library materials, technology, or workforce development upgrades. Funds for these vital programs have been drastically reduced since 2008-09 due to the elimination of state funding for the Instructional Equipment program. The community colleges have had no state funding available to repair, replace or augment their instructional equipment and library materials inventory for the past three years. In an era of rapid technological change and growing dependence on technology and computers, it is critical that students and staff work with up-to-date facilities and equipment used in the work place. In addition, the disinvestment in instructional materials has the potential to be an accreditation issue.

• Professional Development (20%) - High quality professional development for faculty and staff is essential to supporting the effective operation of our colleges. Unfortunately, due to budget cuts, dedicated funding for this purpose was eliminated from the state budget several years ago and local funding is very limited. Dedicating one-time funds for professional development for faculty and staff in the areas such as student success, institutional effectiveness, and online education would be a high-yield investment in our colleges. These funds will help our colleges to implement effective practices in these areas.

<u>Budget Year</u> - If the final budget assumes the higher revenues estimated by the LAO, the CCCs would stand to gain significant increases in budget year revenues. Assuming an 11% split of the CY P98 increase, CCCs would be in line to receive about \$176M in new funds.

<u>Priorities</u> – Priorities for additional funding are consistent with our position throughout the spring to balance available resources among student success and support programs, access, and rebuilding the purchasing power lost due to the foregone COLAs of recent years.

With this approach in mind, we suggest the following priorities for additional funding in the 2013-14 fiscal year:

- Categorical Restoration (\$48.4M)-
 - ➤ EOPS \$15M
 - > DSPS \$15M
 - CalWORKs \$12M
 - > Part-time Faculty Office Hours/Health Insurance \$4.2M
 - > CARE \$2M
 - Academic Senate \$149K

The revised 2009-10 budget reduced ongoing funding for student support programs by \$313 million or an average of 42 percent. Cuts varied by individual program and ranged from no cut to total elimination. Many of these programs provide critical support services to students, such as counseling, orientation, and tutoring, which are vital in enhancing student success. Other categorical programs provide funding to support specific instructional programs or specific disadvantaged populations. In order to preserve core student support programs, we request that the state begin the process of reinvesting in student services by partially restoring funding to key categorical programs. As detailed above, we propose significant funding increases for DSPS and EOPS, CalWorks, and the CARE program. Additionally, we recommend full restoration of the Part-time Faculty Office Hours and Part-time Faculty Health Insurance programs to true up key compensation areas that support our part-time faculty. We also recommend full restoration of support of the Academic Senate to enhance efforts to improve student success, approve SB 1440 degrees and continue progress toward developing common course IDs.

- COLA Restoration (\$88M balancer) Due to the deteriorating economic situation, the state did not provide COLAs to the colleges beginning with the fiscal year 2008-09. The price index specified by law for the community college COLA calculation is identical to that specified for K-12 education, the state and local government price deflator published by the federal government. Cost-of-Living-Adjustments have not been received since 2007-08, and have now grown to a cumulative loss of purchasing power totaling 18.3 percent, or \$994 million. This represents a significant loss in purchasing power to the colleges, as they experience rising expenses in the form of utility bills and health care costs, among other expenses. While the May Revision proposes to fund the 2013-14 COLA of 1.57%, this allows CCCs to keep pace with this year's rise in costs, but it doesn't address the loss of purchasing power accumulated over the last several years. We note that K-12 tracks a "deficit factor" to account for the foregone COLAs in their system, strongly implying intent to catch up to the true cost of funding services provided. CCCs have the same need to restore purchasing power to appropriately serve students.
- Access (\$20M) While the May Revision proposes to restore access by 1.63%, increasing this number would allow CCCs to make further progress toward serving the populations that missed out on higher education in recent years due to the severe budget reductions brought on by the recession. Our headcounts are down by approximately 470,000 since the 2008-09 fiscal year, and more funding for access would allow us to serve more of these individuals before they place higher education into their rear view mirror. These additional funds would allow us to serve approximately 9,000 more students. Data indicates that students with some college education earn more and are much more likely to be employed, so this investment would yield great benefits to the state.
- Student Success and Support (\$20M) Additional investment beyond the Governor's proposed level would allow for even faster progress toward improving student success rates by providing students with more counseling, advisement, orientation, assessment, education planning, and other supports. In concert with the funding proposed in the May Revision, these additional funds could also address basic skills and transfer issues.





Dear MPC-

Good morning. As many of you know, we are facing more difficult challenges related to funding. During Flex Day to start the term, we reported that the District was operating with a \$1,500,000 structural deficit. This was based on the assumption that MPC would make our enrollment goal (apportionment cap) of Full Time Equivalent Students (FTES) for 2012-2013, hire all 7 vacant full-time faculty positions, and that wage concessions would expire at the end of this fiscal year. We have compiled our P2 report and we know that we will not make our apportionment FTES cap for 2012-2013. While P2 reporting of FTES is not the final counting of FTES for the District in 2012-2013, we are currently shy 337 FTES and this level of shortfall cannot be generated from this point forward. We did not make this cap in 2011-2012 and therefore have two consecutive years of low enrollment and the state will adjust our funding down in proportion to our FTES shortfall. This will contribute to our structural deficit considerably.

MPC has made some very impressive efforts to meet this cap. Many of our efforts have yielded increased enrollment in some areas. We will continue to focus on the goal of financial solvency and FTES generation as <u>one</u> of the ways we approach that goal.

There will be an open forum 8:00 – 9:00 AM this Friday in LF 103 to provide more information about the budget shortfall and listen to your inputs.

As always, our MPC community will come together and meet these challenges with grace and an eye on keeping our institution great.





MPC hosted a symposium on Saturday, May 21, entitled "Hungry and Homeless in Paradise: toward a Whole Community approach to issues of poverty," with over 250 people in attendance. The event was organized by members of the Social Science Division, Counseling, Trio Student Support Services, and the Nursing office, with outstanding support from many classified employees in security, maintenance, and media. The plenary address by County Supervisor, Jane Parker, outlined the difficult economic situation our local population faces, with jobs in hospitality and agriculture unable to pay enough to afford housing. While the county is working to improve affordable housing and healthcare for the needy, much more needs to be done. The waiting list for assisted housing is five years long and the number of chronic homeless in Monterey County is at least 3,000, many of them women, children, and veterans. After the plenary address, there were productive discussions led by several MPC faculty, including Alan Haffa, Elias Kary, Kendra Cabrera, and Joseph Anderson, with other facilitators from the Mediation Center at the Monterey School of Law.

This event brought together all the community stakeholders including non-profit providers, faith based groups, local policy makers and staff, businesses, residents, and the homeless themselves. It is hoped that this will help to forge collaborations that will identify positive and effective solutions. In summary, holding a forum at MPC and enriched by our MPC faculty is another example of how MPC adds value to our communities. A special recognition for Alan Haffa who made this event possible and who's passion and expertise made it so successful.





ASIST is a two-day practice dominated workshop that trains professionals and other community providers in suicide "first-aid". Participants are trained how to recognize and assess the potential risk of suicide. MONTEREY - Heinz Helmuth Hubler, age 78, passed away May 16, 2013 in Orem, Utah. He was born September 26, 1934 in Biel-Bienne, Switzerland to Gottlieb and Alice Zenger Hubler.

Heinz was also an accomplished photographer and frequently had his work pub-

lished in travel magazines.



The Marine Advanced Technology Education (MATE) Center, the National Science Foundation, and the Marine Technology Society's (MTS) ROV Committee invite you to our 12th Annual International Student ROV Competition.

Fifty-five teams representing middle schools, high schools, home schools, after-school groups, community colleges, and universities from 18 different states and 13 different countries are scheduled to compete in this year's event, which is being held June 20-22, 2013 at the Weyerhaeuser King County Aquatic Center in Federal Way, WA, USA.

This year's competition theme highlights the role that ROVs play in the installation, operation, and maintenance of ocean observing systems, which are collections of high-tech instruments above and below the waves that provide around-the-clock information about what is happening in the ocean. Participating teams will perform a variety of missions, piloting their ROV to install a simulated power and communications "hub" and scientific instruments in order to complete a seafloor ocean observatory. They will also remove biofouling organisms from instruments and perform maintenance on moorings, among other tasks.

Each year the competition challenges students to think of themselves as "entrepreneurs" and transform their teams into companies that design, build, and market their "product" as a way to better understand the breadth of real-world business operations. During the event, a panel of judges – professionals representing industry, science, government, education, and exploration – will evaluate the companies on their ability to effectively communicate their vehicles' design and construction via technical reports, poster displays, and engineering evaluation interviews.

The competition will also feature the Ocean Career Expo, organized by the MATE Center and its partners in the Centers for Ocean Sciences Education Excellence (COSEE).

I was pretty amazed to get a great number of emails about my last column and the healing powers of the ocean.



I want to thank former MPC football coach and legend, Chris Pappas for starting the ball rolling for Part 2 of the "healing powers of the ocean."

The following quote by Karen Blixen from "The Deluge at Norderney" pretty much sums up my main point for this column.

"Do you know a cure for me?"

"Why yes," he said. "I know a cure for everything. Salt water."

"Salt water?" I asked him.

"Yes," he said, "in one way or the other. Sweat, or tears, or the salt sea."

Coach Pappas called me about the Mauli Ola Foundation (www.mauliola.org), which started in Hawaii, but has held camps in Southern California.

"The Mauli Ola Foundation began as a group of surfers who banded together to introduce surfing as a natural treatment to people with cystic fibrosis. Since 2007, Mauli Ola has taken nearly 1,300 cystic fibrosis patients surfing at nearly 100 Surf Experience Days and has now expanded its reach with hospital visits and other activities that touch the lives of kids with cancer and a variety of other health challenges. In 2010, the Mauli Ola Foundation was awarded The Agent of Change Award by SURFER Magazine for its positive contributions and example to the surfing community."

I have mentioned the Paskowitz Surf Camp (www.paskowitz.com) before as well as the Surfers Healing Foundation (www.surfershealing.org). They are located in Southern California and do great work especially with autistic children.

"We are the longest running surf camp in the United States. Our mission is to continue the Paskowitz legacy of teaching beginners to surf. But we want to instill more then that for most of you will become surfers. We will teach you the correct basic skills to stand up then you will ride waves standing on your own.

"We started the business of surf schools and will always maintain the best surf instructors in the world. The formula for success is simple: Go at your own pace, warm water, sunny beaches, great people in the water and on the beach and delicious food. We are a small, family-run business with a family of staff that are professional, fun and really love what they do.

"For over three decades the Paskowitz Surf Camp has been teaching people how to surf. And in doing so we have given the beginner, the novice and the experienced surfer a sense of self-confidence that can only come from an exuberant interaction with nature.

"Our credo, spread the aloha, is a welcome for everyone; young, middle-aged, mature, woman, man, black, white, fearful or brave, to come and experience the joy of surfing a wave.

"In giving everyone a chance to feel the surge of one of natures most awe-inspiring forces, the Paskowitz family is following in the beloved tradition of surfing patriarch Paskowitz, who has spread the gospel of Aloha from the shores of Oahu and Kauai to the sands of Cabo San Lucas and San Onofre."

"Salt water is my cure. It is my mantra, my mistress and my soul," Will Howell said. "It beckons me early in the morning and at sunset to its healing liquid gold. It can't be fully explained, but only experienced."

Philanthropists make gift to support financial aid, faculty development at York

On May 2, York School announced that philanthropists Peggy Downes Baskin and Jack Baskin donated \$770,000 to York School to be added to the endowments for financial aid for students and for the professional development of the faculty.

Jack Baskin's grandson, Elun Gabriel, is a York alum, Class of '89, as are Peggy Downes Baskin's two stepdaughters, Alison Downes Scott ('75) and Kelley Downes Stanley ('73) and her son Scott Dewar ('74). Peggy Downes Baskin's daughter, Cammy Torgenrud, teaches psychology and is director of technology at York, where she has taught for 19 years.

Peggy Downes Baskin's former husband, the late Chuck Downes, was York headmaster from 1966 to 1974.

The Baskins, who live in Carmel and Santa Cruz, are prominent benefactors of community organizations and education, including York School, CSU Monterey Bay and UC Santa Cruz. Jack Baskin is a retired real estate developer whose gifts established the Baskin School of Engineering at UC Santa Cruz, the Community Foundation of Santa Cruz County and the Jack and Peggy Baskin Center for Philanthropy in Aptos. Peggy Downes Baskin, Ph.D., is a retired political science professor who has co-founded the Women's Leadership Forum at CSU Monterey Bay, Women Helping Women at Monterey Peninsula College, and The Women's Fund of the Community Foundation of Monterey County.

Distance ace Victoria Alcala was third in the 3,000 steeplechase and fourth in the 5,000 for the Panthers while Jessica Mattos placed fourth in the discus and Amy Johnston was seventh in the 1,500.

CCS track & field

Jayla Scholis of Seaside and King City's Jessica Davis will lead a contingent of local qualifiers into next Friday's Central Coast Section track and field finals.

Scholis, the defending CCS 200 meter champion, easily qualified in the 100 and 200 at Saturday's trials in Gilroy while Davis had the fastest time in the 100 hurdles and advanced in the 300 low hurdles, where she is the defending section champion.

Reigning CCS long jump champion Marcus Washington of Palma surivived the final cut as did teammate Chase Pacheco in the high jump.

North Salinas' Mario Gonzales had the third best throw in the discus while Monterey distance ace James Welsh is moving on in the 1,600, and Trevor Wason of Salinas in the 300 intermediate hurdles, and Salinas' 1,600 relay team

Alex Lathos lowered her Notre Dame school record time in the 800 to move on, as did Seaside's Tatiana Lee in the 400.

CCAA regular season champion Cal State Monterey Bay baseball team's season came to an end Saturday in the NCAA Division II tournament playoffs at Bruce Hurst Field.

The Otters were limited to just five hits by Sonoma State in their second elimination game, falling to the Seawolves 4-1. CSUMB defeated CCAA tournament champion Cal State L.A. on Friday, 8-1 in its first elimination game.

Health care, public policy, shelter among topics

There are 2,500 to 3,000 homeless people in Monterey County. Half are classified as "chronic homeless," meaning they have a documented disability or have been without a residence for a year or longer. The county has about 250 homeless families.



"These are the people we can find, and the people who fit a very strict definition of 'homeless,'" said Supervisor Jane Parker, keynote speaker at United Way Monterey County's "Hungry and Homeless in Paradise" symposium Saturday at Monterey Peninsula College. "If you start to think about the number of families who are living in a garage, or crowded into one bedroom at the home of a friend or relative, or sleeping on a couch, the numbers go much higher very quickly."

The ugly truth in "paradise" is that the majority of locals who are fortunate enough to be employed are also in dire straits: More than half the jobs in Monterey County pay minimum wage or less — a fact that brings up another dismal set of statistics.

"There's a table in the weekly home report that shows how many hours a person earning minimum wage must work to afford an apartment in Monterey County," Parker said. "To live in a studio apartment in our area, a person earning minimum wage must work 83 hours in a week. To afford a one-bedroom apartment, the number is 94 hours. A person needs to work 108 hours in a single week to pay for a two-bedroom apartment, and 152 hours for a three-bedroom apartment."

Those figures do not include food, utilities, car repair, medical bills or any other necessities that might compete for a person's dollars, she said.

Those stark realities were the rallying cry that attracted hundreds of residents — some homeless — to MPC for a five-hour summit designed to identify the issues surrounding homelessness and to discuss possible solutions.

The symposium comes as the Monterey City Council is set Tuesday to discuss possible new ordinances to address frequent complaints from residents, tourists and the business community about homeless people and panhandlers downtown and in other areas. One ordinance under discussion would make it a crime to sit or lie on sidewalks or other public spaces.

10-year plan

Saturday's symposium featured breakout sessions on topics that included health care, public policy, faith-based initiatives and shelters. The sessions were largely town-hall style gatherings that solicited input from those attending.

One session was titled "Our Community's 10-Year Plan to End Homelessness." The plan was created in 2010-11 by HomeBase/Center for Common Concerns, a nonprofit public-policy law firm based in San Francisco, using input from "a wide array of community stakeholders."

The plan, accepted by the boards of supervisors in Monterey and San Benito counties, calls for access to housing and housing services, and transition services for people who have just been released from jails, medical facilities and foster programs.

Much of the strategy involves streamlining processes, improving communication and eliminating the bureaucratic red tape that tends to clog the system.

"Let's say a single male comes to a shelter that is for women and children only. So that person is told, 'I'm sorry, you don't qualify here.' That person then might have to go from program to program to program, trying to find

http://www.montereyherald.com/ci_23275211/monterey-symposium-examines-homelessness?IADID=Search-www.monter somewhere to be, and therefore might be more likely to simply give up," said HomeBase attorney Carolyn Wylie. "Instead, we'd have a coordinated system in which the person could make one telephone call, or be sent to a center that is a one-entry point. It would be a coordinated system where all people could go (to find solutions to their problems)."

Looking for solutions

Audience members pointed out specific issues commonly faced by the homeless, including what they called a tendency to regard them as "second-class citizens" and to dismiss their problems.

They suggested a need for free transportation to get the services they require. They asked for more responsive, more flexible agencies. They advocated local jobs that pay a living wage, and more affordable housing.

"I think it's important to try to lower the cost of living, rather than try to increase income, for the homeless," said Charles Wilson, a Peninsula resident with homelessness in his history and a computer science degree on his résumé. "Rent should not be more than one-third of income for anyone."

Another woman called for the decriminalization of homelessness and an end to harassment by law enforcement officers of people living and sleeping in public places.

One homeless man, who said his street name is "Bones," said current laws make getting assistance difficult for anyone with a felony drug conviction.

"It's against federal law for drug offenders to use federal funds for a lot of this stuff. I don't have any drug convictions, but I have felonies on my record, which is what's holding me back from getting a real job," he said. "People who have serious drug problems and get out of prison and can't get their stuff together because of these federal laws that stand in their way ... that really screws things up for everybody. The guy is on the street, he's a drug addict, he doesn't have a job, he can't get any kind of federal assistance because it's against the law, and the cycle just continues."

Local golf notebook: MPC's Phillips inducted into California JC Hall of Fame

When, after 30 years of patrolling the sidelines, former Monterey Peninsula College football head coach Luke Phillips said he wanted to step down, school officials granted him his wish.

But there was also a catch.

"They said yes but went on to say they didn't have a golf coach," Phillips said. "So they told me they were going to reassign me. I said show me where I sign up."

Turned out, it was another great move for Phillips.

Last week, Phillips, now 85, was inducted into the California Community College Men's Golf Coaches Association Hall of Fame. He's the only coach to be a member of two California Community College Athletic Association Hall of Fames, having previously been tabbed for the football hall.

During his tenure as golf coach at MPC (1987-2001), the Lobos racked up eight Coast Conference titles, six NorCal Championship crowns and one state title. The state title came in his inaugural season at the helm.

"I had never really coached golf," Phillips said. "When we won state my first year I thought, 'Well, this is easy.' I was fortunate to have some great players."

Some of those who went through Phillips' program include current Lobos head coach Justin Russo and Cypress Point head pro Casey Reamer, former NorCal champion Santana Steudler and former Arkansas All-American Andrew Dahl. Others who'd go on to turn pro include Jason Lotz, Steve Carter and Bill Greenlee.

Taking from his football days, Phillips used coaching mantras such as attitude, promptness and respect for oneself and others. He also made sure his players had their own swing coach.

"I was more of a manager than I was an instructor," Phillips said. "Some of the guys had to be disciplined, they wouldn't play by the rules. A lot of the kids had really big egos. But they were different than football players. Just different athletes."

Along with having talent, Phillips also had the backing of the Monterey Peninsula golf circles. Among those Phillips said were instrumental in his success were Pebble Beach Co. Senior Vice President of Golf RJ Harper, late Rancho Canada/Laguna Seca Golf Ranch owner Nick Lombardo, former Monterey Peninsula CC head pro Mike Chapman, current VP director of Rancho Canada Todd Pontti and former Cypress Point head pro Jim Langley.

"They all provided access to their courses," Phillips said. "I got a lot of help from the local golf people."

Getting to play Spyglass Hill, Pebble Beach GL and Cypress Point didn't hurt with recruiting either. At one time or another, MPC featured players from Japan, Sweden and England.

"When I was recruiting, I just had to send out postcards of the local courses," chuckled Phillips. "It was an advantage a lot of coaches didn't have."

Upon Phillips' retirement, former Stevenson golf coach Wally Goodwin, who'd since moved on to coach Tiger Woods at Stanford, noted that his friend was "a great coach." "Luke is spirited and humorous and has a great rapport with the kids," Goodwin said.

"It was a great journey for me and added so much to my coaching career. It was the best coaching job a golf coach could ask for. The amenities, the people, the environment," Phillips said. "I've always been fortunate to be in the right place at the right time. I don't take any of my success for granted. I really enjoyed it."

Tiger at Frys.com Open?: The odds that Tiger Woods will play in this year's Frys.com Open at nearby CordeValle GC look pretty good. Why? Woods will host his private Tiger Woods Invitational at Pebble Beach, a fundraiser for his foundation, on Oct. 14-16. The Frys.com Open, which will open the 2013-2014 PGA Tour season, is on Oct. 10-13.

Last year, Woods, Rory McIlroy and six other players including 2012 U.S. Open winner Webb Simpson played in the Turkish Airlines World Golf Final. According to Frys.com Open tournament director Jeff Sanchez, there's an agreement that says as part of Woods and those players' release to play in Turkey, they're obligated to play in the Frys at least once in 2013, 2014 or 2015.

Being that Woods' Pebble Invitational begins the day after this year's Frys, one has to wonder if he'll start his Northern California visit at CordeValle. Then again, Woods usually only visits his Invitational one of the three days to put on a private clinic.

"We don't have any commitment from Tiger, but we'd love to have him," Sanchez said. "It'd be a tremendous boost to the field to have the No. 1 player in the world and the No. 1 draw in golf. We're hopeful he'll support us this year. It'll be the first year to fulfill his obligation."

Watching Cal: Among those keeping an eye on Cal Berkeley's record season have been Palma senior Jay Burlison and Stevenson junior Seb Crampton. Burlison signed with the Bears in November. Crampton has committed and will sign this fall.

"It's very impressive. I've got some big shoes to fill, no doubt," Crampton said.

"I think it's awesome," Burlison said. "I can't wait to get around those guys. I think they'll make me better."

Both Burlison and Crampton went with Cal due to the coaches, the golf program and the academics.

"For me, they were the perfect combo of great golf and academics," Burlison said.

According to Burlison, after he signed he "hounded" Crampton to go to Cal. The two discussed it during a casual round with Michael Decker at MPCC.

"I really like Seb's game and he's a great guy," Burlison said. "It's going to be a blast."

*Lauds mayor for sensitivity to homeless



Seaside's Open Ground Studios brings artists together

Art is often not created in a vacuum. That's why a group of local artists and Monterey Peninsula College art students founded a communal studio in Seaside.

The idea took root last spring when a group of students started talking about a need for space to work, said Denese Sanders, an MPC art teacher, artist and the studio's founding director.

They asked, "How could it be a community studio?" Sanders said Friday night at a party for about 50 invited guests at Open Ground Studios, which had a public grand opening celebration Saturday. "Community is what makes the world go round."

The studio, which Sanders said is the only one of its kind on the Monterey Peninsula, will offer equipment, artist work space and instruction in drawing, printmaking and book arts.

This month, Sanders' studio won the Monterey Bay Regional Business Plan Competition. The money from that award helped fund equipment and supplies.

"I love it," founding artist Debra Smith of Prunedale said of the new space. "Working by yourself, it's OK, but working in a community you see other people's work and it inspires you."

Pacific Grove printmaker Susie Berteaux said she "gets new ideas and techniques from other people, and helping other people with their work really helps me."

Aside from inspiration, there are practical reasons for the studio, Sanders said.

"Studio space is extremely expensive in Monterey and artists are hesitant to rent if they are not sure if they can be productive by themselves," she said.

"People need community to work in. Solitude can be great in some cases, and it can be limiting as well," she said.

The studio signed a one-year lease in February at 1230 Fremont Blvd. with landlord Edward Lo, who allowed the group to hold meetings there until they could gauge the level of support.

"This is a community effort," Sanders said. "I am leading it, but I am not leading it alone."

The studio has memberships at varying price levels, including those for founding artists and for the public. Sanders likened the general memberships to museum memberships.

A February membership drive signed up 11 founding members and about 30 general members.

"We can take as many general members as possible," Sanders said.

There will be eight, five-hour open studio sessions a month, which could be good for artists who can work independently but who perhaps have a large project and need room to spread out, Sanders said.

A community gallery space is available to rent for art exhibitions and other events, and master class workshops taught by Fellows of Open Ground Studios (FOGS) are offered by "highly respected local and visiting artists," according to the studio's flyer.

Monterey print- and quilt-maker Roberta Brunet, a former student of Sanders, said Saturday she was immediately

"I came on a Friday afternoon and within an hour I plunked down my money," said Brunet, adding that she had no room to work at home.

"There are a lot of artists that need space to work," said Sandra Gray of the city's art and history commission, who attended Friday's party along with Mayor Ralph Rubio. "It's very hard to have a space in your own home sometimes."

Space isn't the only issue the studio addresses. Starting in July, MPC art students are subject to a new rule that no longer allows them to repeat art classes, Sanders said.

"For lifelong learners who have started to learn an art form, if they are not ready to be fully independent they are going to need a place to continue to practice with guidance," she said.

Sanders, an adjunct instructor, said she was also aware that with budget cuts at community colleges, her position could be in jeopardy.

"I had colleagues and friends who were all saying they wanted to have a community studio that would enable them to practice art independently of an academic environment," she said.

Sanders said the struggle for artists in today's world is never-ending.

"The arts are really difficult. It's hard to succeed in the arts, especially in this economy," she said. "I hope the Monterey Peninsula will embrace it."



So, I take it everyone has had their fill of great music over the long Memorial Day weekend? There was funk, R&B, reggae rock, country, roots rock, blues, retro soul and even more reggae rock.

The California Roots Festival sold out all three days and I took in both days of the Santa Cruz Blues Festival, one of my two favorite music festivals of the year (the other is my longtime favorite, the Monterey Jazz festival). There was also the Clam Chowder and Calamari Festival, which had three days of bands and music.

But one of the best shows of the weekend was last Friday's performance at the Golden State Theatre by He's My Brother She's My Sister, which I believe is one of the best club shows I've seen in years, certainly one of the two best lobby shows I've witnessed (Soft White Sixties and Stone Foxes are right up there).

The band, which features a tap-dancing percussion dynamo (Lauren Brown dances on top of a bass drum while playing three floor toms), upright bassist, lap guitarist and the brother-sister singing tandem of Robert and Rachel Kolar.

The band plays with a ton of energy, passion and humor and has a solid catalog of great tunes, many taken from the latest album "Nobody Dances in This Town" (check out "Clackin' Heels" for a good, toe-tapping chuckle). I hope they return, my guess is at a bigger venue with a couple of hits under their colorful belts.

OK, so onward and upward, not to rest on any laurels, there are a raft of great shows this week, perhaps not on par with Slightly Stoopid or Tedeschi Trucks Band (one of the highlights of my weekend), but solid nonetheless.

On the local front, several developments. Soulful singer Jaqui Hope will be performing her last show at the Monterey Plaza Hotel's lounge on Friday night from 5:30-9:30. Hope will be pursuing other opportunities in the area, but I'm sure we'll be seeing her singing again...somewhere.

Joining her will be keyboardist Bill Spencer, who himself is moving on to other opportunities, which I'm not sure I can divulge just yet. He can be found with his own band, Bill Spencer & Prime Pocket, Thursday night at Sly McFly's.

Jazz singer Scotty Wright is a busy man, playing with his band, the Fry-Wright Band,, as well as Aporia, but Thursday night from 7-9 he'll be playing the new Safari Club at the Bay Park Hotel just off Highway 1 and Munras Avenue in Monterey.

Wright will be joined by pianist Bob Phillips, bassist Pete Lips and saxophonist (also with Aporia) Stu Reynolds. Ten bucks at the door helps the promoter Kiki Wow pay the band.

Speaking of Phillips, he's playing Saturday night at the Hyatt Regency Monterey's weekend jazz sessions. On Friday night you'll find local guitar legend and Barry Manilow axeman Mike Lent dazzling the crowd. That's 7 p.m. both nights, no cover.



And former Lent bandmate and bassist extraordinaire (and he plays a mean guitar, too) Dennis Murphy plays host to the 30-voice jazz ensemble Urban Renewal, which holds its spring concert Friday night at 8 at Monterey Peninsula College Music Hall.

Special guests that night include Franklin Street Voices as well as the small group Baker's Dozen.

The combo backing all these voices include saxophonist Gary Meek, keyboardist Michael Martinez, drummer Mike Shannon and possibly Murphy on bass, although he's also a member of Urban Renewal so we'll see how well he



MONTEREY - Heinz Helmuth Hubler, age 78, passed away May 16, 2013 in Orem, Utah. He was born September 26, 1934 in Biel-Bienne, Switzerland to Gottlieb and Alice Zenger Hubler.

As a young man, Heinz wanted to have a career as a watchmaker, but found that his poor eyesight



prevented this. Heinz served in the Swiss Army Reserves and then moved to the United States, eventually attending Brigham Young University (BYU) to pursue a degree in sociology. It was at BYU where he met the former Carolyn Cartwright, whom he married in 1956. Following graduation from BYU, he en-

listed in the U.S. Army and served for two years, being stationed throughout the United States.

After his military tour of duty, Heinz began working for the Red Cross, eventually finding himself in Vietnam, just shortly before the War. He was then transferred to Monterey to work with the Red Cross at the former Fort Ord. After two years at Fort Ord, he became the new Community Services Director at Monterey Peninsula College (MPC). He was employed by MPC for the next 25 years. His duties included organizing events and entertainment, community classes and curriculum and also starting a travel study program

Following his retirement from MPC, Heinz started a travel business, and guided tours not only to his home country of Switzerland, but to many destinations all over the world. Heinz was also an accomplished performer and singer; and briefly as a young man staged an amazing balancing act as a circus performer. Heinz was also an accomplished photographer and frequently had his work pub-

lished in travel magazines.



MPC Meeting of the Board of Trustees: June 26, 2013 Superintendent/President's Report: Dr. Walt Tribley

- 1. MPC graduation ceremonies ran smoothly and were well-attended. From the certificate-generating programs to the general commencement, the events were very meaningful. With 204 students walking at our general commencement, 2013 was a great year for student participation.
- Presented budget-related information to the campus community in an open forum, as well as to Academic Senate and College Council. The purpose of these meetings was to provide transparency and clarity as to the issues that face us and the short-term actions we are taking to help offset our FTES deficit.
- 3. Met with Trustees Dunn Gustafson, Steck, and the President of the Gentrain Society, Mr. Breedlove regarding the issues facing non-credit courses for life-long learners in the CCC system. We discussed the timing of proposed policy changes that would negatively impact apportionment funding for non-credit FTES/lifelong learning courses. The Fall of 2015 will be the first semester that would be impacted by previously-proposed policy changes, if those changes are implemented. The college remains in strong support of Gentrain and other lifelong learning opportunities for our communities, and will continue to run pilots of such courses via community education to prepare for the possibility that funding will be eliminated and the college would need to rely solely on community education to deliver lifelong learning courses.
- 4. Attended the retirement celebration for Mr. Anderson as well as a celebration for Professor Fuller.
- 5. CalWorks, EOPS/CARE & TRIO/SSS ceremony. What a testament to the great work our student services and faculty do with our students.
- 6. Attended the Scholarship Ceremony. MPC students received a record amount of scholarship funding this year.
- 7. Attended the Seaside HS scholarship ceremony with Trustee Brown and Mr. Birt Johnson.
- 8. Employee recognition BBQ was a huge success and a great team-building event for all MPC employees. A list of all awardees was distributed to All Users. Mr. Carsbia Anderson's last BBQ was well-attended.
- 9. Attended the Citizens' Bond Oversight Committee meeting.
- 10. Interviewed candidates for several open faculty positions.
- 11. Met with Laura Loop, Michael Gilmartin, Rosaleen Ryan, and Mike Torres regarding the proposed changes to the multi-criterion selection process.
- 12. Met with Celine Pinet, Laura Franklin, and the Math Department regarding staffing mathematics appropriately. I also met with the Basic Skills Committee as they work on prioritizing their projects and budget for 2013-2014.
- 13. Attended the meeting of the board for the South Bay Regional Consortium in May. We were provided an update to the Chancellor's Office's review of the consortium. The review is ongoing and the consortium is preparing a draft of a response document for the Chancellor's Office regarding their review. I articulated MPC's position regarding the need to retain the 45%-55% split of apportionment revenue (45% retained by the participating colleges in the consortium) as

there was discussion related to the possibility to increase the percent that the consortium retains. MPC staff has participated in other meetings related to the consortium since that meeting to address issues pertaining to admissions and records, publication of course information, as well as curriculum alignment.

Executive Summary

It was a year of rapidly accelerating change. Things are changing faster than I've ever seen in the Community College System. Either that, or I'm finally figuring out what's going on. People that know me well tell me it's probably a little bit of both.

We said goodbye to our previous President and wished him well in retirement. We welcomed a new President to the college and wished him well in his efforts to navigate us through this new landscape of increasing demands and decreasing resources.

The Student Success Initiative, the Chancellor's Office Scorecard, and the accreditation agency among others all continue to press for ever-more accountability in an environment of decreasing resources. Legislators clamor for increased numbers of graduates and transfers from our system, even suggesting the use of online courses developed by outside vendors to ensure student access to classes. Accountability demands are leading to numbers without context, a worrisome approach that invites inappropriate comparisons and misbegotten conclusions. Media outlets and critics seem to love data summaries like the Scorecard because it's quick, easy to work with, and generates controversy. Those in academia hate it because data quality and the context that support the data are left behind like discarded cigarette butts along the roadside. They worry that suggested shifts in funding models from accessibility to completion will cause the value and meaning of a college education to decline. State Academic Senate President Michelle Pilati summed it up well, saying that the community colleges are operating in an "environment that is effectively encouraging a diminishment of quality while asking for a product of demonstrable value" (March 2013 update http://www.asccc.org/newsletter_archive).

MPC faced these types of issues early in the academic year when it tried to respond to a sudden change in the Chancellor's Office requirements for Basic Skills funding requirements. With little notice late in the previous academic year, the Chancellor's Office released a new reporting mechanism that required all funded activities be tied to quantitative "success goals" based on cohort data provided by the Data Mart Cohort Tracking Tool. In response, the MPC Basic Skills Committee tried to establish "success goals" that established a percentage increase in students progressing through certain basic skills courses. Faculty members on the Basic Skills Committee, along with members of their departments, had serious concerns about the report format and approach, essentially saying that basing an evaluation of a project solely on quantitative data without any supportive context is wrong and potentially misleading, and that it represents a shift in philosophy away from a holistic approach supporting all students to a myopic focus on progression in English and Math. Like a slap in the face on a cold morning, MPC was introduced to the new quantitative accountability paradigm.

It is within this environment that the MPC Academic Senate operated this year. Trying to be proactive in a reactive environment, the Academic Senate looked for ways to define, promote, and protect the meaning and quality of an MPC education while at the same time recognizing that it needs to participate in the accountable world in which it operates. It hoped to develop and implement processes that provide context to those quantitative metrics that are becoming an increasingly prominent part of our landscape.

Recognizing these challenges, the Academic Senate endeavored to provide the context and meaning for the quantitative metrics we continue to see. The SLO Committee submitted a "platform" that envisioned more prominence for learning outcomes and encouraged the college to become an outcomes-based institution by participating in both the quantitative and qualitative aspects of the SLO process. It is only through engaging in both quantitative and qualitative methods that the institution can convey the story of

the whole institution without forgetting the faces of the students that it serves. The SLO Committee and the Academic Senate continue to strive to create and implement procedures that are flexible enough for each division and department to use as a framework for addressing their own issues and needs.

In accreditation matters, the Academic Senate reviewed and recommended submission to the ACCJC (Accreditation Commission for Community and Junior Colleges) follow-up reports, a mid-term report, and material to be included in its annual report. In response to the follow-up report, the accrediting agency informed the institution that it had removed the deficiencies for two of the recommendations, but that deficiencies remained for the other two. These remaining deficiencies, in part, led to the development of the platform to encourage the college to become more of an outcomes-based institution.

The MPC Academic Senate participated in the institution's ongoing board policy review efforts with the idea of quality education in mind. In its recommended policy revisions, the Academic Senate endeavored to ensure that faculty primacy is retained in recommendations to the board regarding academic and professional matters such as curriculum and program development. The Academic Senate approved 16 board policies to be forwarded to other shared governance groups for eventual recommendation to the President to be brought to the board.

If an institution wants to promote and maintain quality, it must be able to define it, talk about it, and recognize it when it sees it. To that end, the Academic Senate collaborated with the Institutional Committee on Distance Education to develop a rubric that articulates the characteristics of quality in the online classroom. These guidelines are intended to form the baseline for faculty training and mentoring as the institution continues to increase its offerings in this area. The rubric deals with all aspects of teaching online, including both technical issues and pedagogic issues that arise when teachers don't see their students face to face.

Attaining a quality education is often a difficult undertaking for many students. Recognizing that they need support from all sides in order to reach this goal, the Academic Senate sought to improve the collaboration and communication between student services and instructional faculty around issues of transfer and completion. Presentations were developed to educate students and faculty about the new 1440 Transfer Degrees. Plans were initiated to develop 300-level courses that would introduce students to the content of the courses they typically have trouble with as they begin their academic careers. The aim is that these courses will improve student engagement and overall success for those students who may be taking basic skills math and English at the same time.

A more detailed summary of accomplishments related to the goals set at the beginning of the semester follows. Original goals and objectives are in **bold**.

1. Institutional Issues

Feed the accreditation beast (Fred)

In part because of accreditation issues—MPC removing deficiencies in only two of its four recommendations—and in part because of recognition of increased accountability expectations throughout the state, the SLO Committee developed and then shared with the institution the SLO Platform to increase the prominence of SLOs and the Reflections process. The main point of the platform reads, "The institution must act as a team to demonstrate the value of an MPC education by using SLOs to demonstrate what MPC students learn, the degree to which they've learned it, and how the institution has endeavored to improve." It recommended that SLOs and the Reflections process be integrated into institutional goals, component goals, and into the hearts and minds of all MPC personnel. MPC needs to encourage the attitude that in addition to being great educators and service providers, "student learning is what we do and we can demonstrate its quality and value." In addition,

because adjuncts are responsible for so much of the learning that occurs at MPC, they need to be more fully integrated into the Reflections process. The document was unanimously endorsed at the Academic Senate and at all three advisory groups.

> Participate in writing the Mid-Term Report and shepherd it through the shared governance process.

- ✓ Through the SLO Committee and the Academic Senate, faculty members wrote several sections of the follow-up report and then helped present it at various shared governance committee meetings such as AAAG and the College Council.
- ✓ The experience of writing these reports led to several improvements in the SLO/Reflections process.

> Recruit faculty members to participate in this process

✓ Although the spectrum of faculty members involved in writing the mid-term report was not as great as originally envisioned, the report had strong faculty input and was vetted at the Academic Senate as well as other shared governance groups.

Plan flex day events that are informative, inspirational, motivational, and/or engaging to all those that attend (Flex Day group)

The Fall and Spring Flex Days were carefully planned and executed to perfection. Post-flex-day surveys indicated a high level of enthusiasm for the breakouts that were offered and good suggestions for the future. Sessions that had especially high praise were the OnCourse workshop organized by the Basic Skills Committee and the mental-health-related breakouts offered by Diane Boynton and the BART (Behavior Assessment Response Team). For the Fall 2013 semester, the Academic Senate looks forward to a keynote address by Diane Boynton.

> Address the lack of a chair on the Flex Day committee.

✓ Kevin Bransfeild chaired the committee for the Fall semester. Grace Anongchanya and Kelly Fletes took over for the Spring semester. The flex committee is in good hands.

Review Board Policies that relates to academic and professional matters

As part of its discussion on board policy, the Academic Senate made two recommendations to the institution. These recommendations were made in an effort to increase transparency in administrative procedures that are closely related to many of the board policies. Currently, administrative procedures and appendices to board policies are not readily available to everybody. At a later meeting, the Academic Senate made a recommendation about the naming of the President in the Board Policies. It preferred the term "Superintendent/President" over "CEO" in line with MPC's current culture and naming practice.

- Recommendation 1: The Academic Senate recommends that wherever MPC board polices mention appendices or administrative procedures, that these appendices or administrative procedures be published in an easily accessible location, like in the same document, or right next to the board policies on the web site.
- Recommendation 2: The Academic Senate recommends that MPC clarify the distinction between a BP appendix and an administrative procedure, or choose one or the other term and then consistently use it in all BPs.
- Recommendation 3: The Academic Senate recommends that the President be referred to as the "President" or "Superintendent/President" in all of these board policies. The CCLC (Community College League of California) draft policies contain the phrase [CEO], indicating that each institution should choose their own phrase. The Academic Senate believes the term "CEO" is too corporate for the culture at MPC.

- > Participate in the new board policy review effort to adopt a large number of board policies this academic year.
 - ✓ The Academic Senate generally took the CCLC draft policies and edited them slightly to make sure they complied with MPC practice and to ensure that the institution relied upon the Academic Senate or Curriculum Advisory Committee for recommendations regarding academic and professional matters such as curriculum and program development.
 - ✓ The Academic Senate reviewed and recommended 16 policies during the academic year. These included:
 - o Instructional Service Agreements (ISAs)
 - Contract Education
 - College Catalog
 - o Graduation Requirements for Degrees and Certificates
 - o Library Services
 - o Open Enrollment
 - Course Repetition
 - o Academic Calendar

Support the continuing development of distance education at MPC (Catherine, ICDE, Fred)

- Work collaboratively with ICDE to establish a philosophy that articulates the role, scope, and meaning of high-quality distance education at MPC
 - ✓ A working group was convened and a rubric describing quality distance education was developed. A rubric previously developed by Chico State was used as a starting point.
 - ✓ The rubric describes all aspects of distance education, including website design, syllabus and outcomes, student support, and assessment and evaluation.
 - ✓ As of this writing, the DE Quality rubric is being reviewed by the Academic Senate.

- > Review the second ACCJC follow-up report and approve its submittal.
 - ✓ This report was completed, reviewed by the Academic Senate and submitted to the ACCJC. The ACCJ subsequently accepted it and "removed the deficiency" related to this recommendation.

2. Goals Initiated by the Academic Senate

Support faculty development and effectiveness by making enhanced use of the existing faculty evaluation process using peer-based mentorship. (Kevin, Andres, Elias)

> Solicit best-practices from around the campus as guidelines for the post-evaluation support of all faculty, both new and experienced, in areas such as:

- Course content
- New use of technology
- Pedagogical strategies
- Student assessment
- Community outreach

- Diversity issues
- Campus service
- Pre-chair mentoring
- MPC Foundation support
- Develop a process to assist evaluation committees with post-evaluation strategies that clearly outline goals, timelines, and support for faculty that will address constructive recommendations born from the information gained during evaluation.
- Dutline a process that will be of benefit to all faculty members, as well as their evaluation committee. It will help maintain a consistent thread of evaluation throughout all stages of our career, and provide an entry point for our next round of self-evaluation and reflection.
 - ✓ Met with Dean Laura Franklin to discuss the current mentoring process and determine how they might work to improve it.
 - Reviewed the recently published ASCCC (Academic Senate for California Community Colleges) paper "Sound Principles for Faculty Evaluation"

 - ✓ Reviewed the ASCCC Spring Plenary Resolution (19.03) "Develop Training Guidance for Faculty Engaged in Peer Evaluations", which directed the ASCCC to work with statewide bargaining organizations and other relevant constituencies to develop training materials and/or orther guidance to help local colleges and districts establish effective training processes for faculty engaged in peer evaluation
 - Became motivated to gain traction in the fall to merge MPC's mentoring process with the best of the ideas from the ASCCC.

Continue to investigate the feasibility of instituting +/- grading at MPC (Steve-our honorary senate representative)

- > Pursue investigation of +/- grading by soliciting information from students.
- Approach student leadership and ask them to do some kind of 'awareness' or 'discussion' or 'focus group' on +/- grading.
- > Analyze the results of the student discussion.

The Academic Senate should determine whether it should pursue this idea next year.

Encourage and improve communication and collaboration between instructional faculty and student services to support student success. (Instructional and Student Services Group)

This was one of the Academic Senate's most successful efforts of the year. In addition to the accomplishments listed below, under the original objectives, this group made substantive progress in two additional areas.

- ✓ Discussions were initiated on creating 300-level courses designed to give students an introduction to traditionally difficult subjects. Rationale for this new type of basic skills class includes
 - Making the first few semesters of a basic skills student's experience more varied and enriching by including courses beyond English and Math
 - o Providing exposure to a major that students might not have otherwise considered
 - Enabling students to make more educated decisions about choosing their major, as the Student Success Initiative will be encouraging students to declare their majors earlier in their education
- ✓ Efforts were initiated to develop informational workshops for students to introduce them to the nuts and bolts of some of the popular majors such as biology. A student survey is

currently being developed to elucidate topics of high interest to students. The workshops would include the following kinds of topics

- o Emphasizing the importance of sequencing courses
- o Providing information on four-year universities to continue their studies
- Offering information on careers in the discipline
- Establish collaborative effort between instructional faculty, counseling faculty and student services staff to develop and present a pilot transfer workshop specific to a discipline or division. The workshop will include information about SB 1440 transfer AA degrees.
 - ✓ In collaboration with the working group, Kim Mansfield and Amber Kerchner developed a presentation about the transfer degrees that was shared with the Academic Senate on November 15.
 - ✓ These pilot presentations were an effort to get instructional faculty feedback, to inform faculty about the challenges and opportunities of transfer degrees, and encourage their participation in future efforts.
 - ✓ They went on to give this presentation to the Humanities and Social Sciences Divisions.
- Initiate a process that explores and cultivates the sharing of SLOs between instruction and student services and programs. Identify areas of shared aims and align strategies to meet students' needs.
 - ✓ The SLO Committee received strong Student Services representation from Grace Anongchanya. Prompts on the Program Reflections form were updated and designed so that programs from across the institution could respond and use the form in a profitable manner.

Address Instructional Technology Issues (Catherine, Alexis, Sue)

- > Summarize past notes on technology concerns (e.g., Tech Triage survey results, minutes from our meeting with Steve Ma last Spring, etc.) to present to the new Director of Information Services and Associate Dean of Instructional Technology.
 - ✓ A summary of technology concerns was developed and given to the new Director of Information Services, along with a box of chocolate, upon his arrival.
 - ✓ Chocolate and pledges of support were also given to the new Associate Dean of Instructional Technology.
- > Invite these individuals for constructive dialog to convey faculty concerns.
 - ✓ The technology concerns collected by the Academic Senate were included in and informed the draft Technology Master Plan currently under review by the institution. Upon presentation of the Tech Master Plan to the Academic Senate, many helpful comments and critique were delivered to the Technology Committee.
 - ✓ A principal result of these comments is that delivery of the final draft of the Technology Master Plan will be adjusted to the Fall 2013 semester so that a truly informative plan that can aid the institution in its planning efforts can be developed and presented to the institution.

Participate in improvement of technology implementations related to instruction and user-centeredness.

- > Prepare a summary of past institutional discussions regarding technology concerns (e.g. Academic Senate minutes, "Tech Triage" survey responses, etc.) for the incoming Associate Dean of Instructional Technology and Director of Information Services to provide a context for technology concerns from the faculty perspective.
- Share the summary of concerns with the Instructional Technology and Director of Information Services.
 - ✓ Accomplishments in these areas are summarized above.

- > Collaborate with the incoming Associate Dean of Instructional Technology and Director of Information Services on plan for addressing the concerns and communicating the response to faculty.
 - faculty.

 ✓ These collaborations took place via the Technology Committee, the DE Quality working group, and presentations to the Academic Senate where feedback and suggestions for improvement were gathered.

I attended my second Monterey County Central labor Council meeting on Wednesday, June 5 2013-giving MPCEA a further reach into the Central Labor Council and joining labor in a call for action on immigration reform and other labor issues.

It appears our negotiations with the District are ending. The District per our agreement gets to keep our COLA- 1.57% because the district did not reach its cap, that and a change in insurance set a sides the District should meet this year's budget shortfall.

Once again MPCEA is thankful for no layoffs.



HIGHLIGHTS OF REGULAR BOARD MEETING May 16, 2013

- 1. Robin McCrae, Chief Executive Officer, introduced Karen Araujo, Interim Executive Assistant. Lori Andre is out of the office for several weeks and Karen will fill in meanwhile.
- 2. Clive Stewart, Program Officer for Genesis House, offered an update on the many recent improvements and repairs to the facility. 26 clients are there now. Mary Carbone will get materials and volunteers for the next phase. The accreditation site survey will be on the 16th and 17th of July. An Open House will be scheduled shortly thereafter.
- 3. Finance Committee member Harvey Kuffner reported the agency is in a good situation right now. It is \$114k ahead in revenue over expenses. A contract pending for providing mental health services will result in an increase of \$90k for CHS when it goes through. The contract amendment for this year and a new 3-yr contract effective July 1 are in the signature phase.
- 4. A budget proposal will come back to the board next month for approval as the fiscal year ends 6/30/13.
- 5. The committee is seeking to refinance two mortgages and is looking at the options offered by two banks (Wells Fargo and Rabobank). A report will be given next month.
- 6. The committee is also comparing and considering line of credit options with Wells Fargo, Rabobank and the Nonprofit Finance Fund.
- 7. Bette Grace & Associates' final review of the agency's retirement plan reflected very positively on the staff and how the organization is run.
- 8. It was determined that Mary Ann Carbone will serve as chair and Curt Parker will serve as vice chair on the FY 13-14 Board of Directors.
- 9. In addition to items mentioned above, next month's agenda will include:
 - Bette Grace & Associates' full report;
 - details on the CPO's request for new computers and software; and
 - the results of Mary Ann Carbone's discussion with Robin McCrae about material prices for stairs at Genesis House, if needed.

The next board meeting is scheduled for Thursday, June 20, 2013, from 11:00 a.m. to 1:00 p.m. at the Sand City Hall, 1 Sylvan Park, Sand City, CA.

Legislative Update

- 1. We have a working budget for the upcoming year. More funding, in general, for the CCC system as predicted overall including funding for a COLA (1.57%). (Staff is reporting on our proposed budget that includes information related to the approved budget from the State.)
- 2. AB 955 Das Williams' (D-Santa Barbara): Bill to allow community colleges to offer extension programs for credit, during summer and winter intersessions. This bill passed out of the Senate Education Committee and is heading for the Senate Appropriations Committee.
- 3. Work on AB 806 AB 806 (Wilk) has been on hold.

MPC Active Bond/Facility Projects Update June 11, 2013

<u>Humanities</u> / Old Student Services / Business Humanities — The project is receiving State matching funds. Phase 1 (Old Student Services Building) construction has been completed. Construction on Phase 2 (Humanities Building) is significantly ahead of schedule, and the new goal for completion is August 20, 2013. Drywall has been installed and interior painting has begun. Ceilings will be installed after the interior painting is completed. Sidewalks and seat walls have been poured, and landscaping work continues. Electrical, mechanical and plumbing work continues. Every effort is being made to complete this project ahead of schedule.

<u>Life Science / Physical Science Buildings</u> – There are two phases in this project with the First Phase being the Life Science building which has been completed. At the Physical Science building, casework and cabinets are being installed. Electrical, mechanical and plumbing systems are almost completed, and testing has begun. The Physical Science building is expected to be completed in July 2013.

<u>Swing Space</u> – The "Swing Space Village" is located adjacent to and south of the Theatre, and classes are being conducted in the building. The General Classrooms Building has been modified and is accommodating the Physical Science department. The plan to accommodate the needs of the Arts Complex and Student Center (food service, book store, and other departments) is being implemented. Modifications to Swing Space will be completed before the commencement of fall classes.

<u>Infrastructure</u> – Site work (lighting, parking lots, sidewalks) will be ongoing for the next few years.

<u>Pool/ Tennis Courts</u> – The project will go to bid in July 2013. It is anticipated work will commence in the summer of 2013.

<u>Student Center</u> – Bids were received and were over budget primarily as a result of extensive seismic and structural work that is needed to receive DSA approval. The overage will be covered by the savings that resulted from the Arts Complex bid that was under budget. Work will commence upon Board approval of the bid. Completion is scheduled for late summer of 2014.

Arts Complex – The Arts Complex project is comprised of the major renovation of the Art Studio and Art Ceramics Buildings. Very competitive bids for this project were received May 14, 2013 resulting in the project costs to be well within budget, and savings will be sufficient to cover the overage on the Student Center. Construction will commence after Board approval in the summer of 2013 with completion scheduled for the summer of 2014.

<u>Music Building</u> – MPC is applying for matching State funding for the renovation of some of the existing Music buildings.

<u>Facilities Committee</u> – The Committee meets on a regular basis to review project budgets and schedules. The last meeting was held May 31, 2013, and the committee was informed of the status of the projects and the forecasted budgets.

Summary: The present budget is now \$10,800,000. The original budget was \$14,500,000, but the bids and construction costs were lower than originally budgeted. As a result, \$3,700,000 has been transferred to other project budgets. The present budget is \$10,800,000 (as approved by the Board in November 2012). The Physical Science building is scheduled for completion in the summer of 2013.

The original budget of \$3,845,000 that MPC was to contribute has now been reduced to \$3,296,000 due to the bids coming in lower than the budget. This results in a potential savings to the MPC bond budget of \$549,000 which may be allocated in the future to a contingency fund. Phase 1 (Old Student Services Building) has been completed. Phase 2 (Humanities Building) construction continues and is ahead of the contract construction schedule completion date of November 2013.
