Dear Dr. Tribley,

Current Nebraska state law specifies that no postsecondary institution shall operate in the state by establishing a physical presence until it has received authorization from the Coordinating Commission for Postsecondary Education (Neb. Rev. Stat. §85-2408).

Physical presence is defined as establishing an administrative office or mailing address in the state or offering a course for college credit or a degree program, including:

- establishing a location for synchronous or asynchronous instruction and
- requiring students to meet in one location for instructional purposes more than once during the course.

Physical presence does NOT include:

- a short course or seminar where instruction for the segment takes not more than twenty classroom
- course offerings on a military installation solely for military personnel or civilians employed on such installation
- an educational experience arranged for an individual student, such as a clinical placement, practicum, residency, or internship
- courses delivered online or through the U.S. mail which do not require the physical meeting of a student with instructional staff (Neb. Rev. Stat. §85-2403).

Clearly, institutions offering exclusively online courses or programs with no physical presence in Nebraska are not required to seek authorization. However, approval by a professional board may be required for certain program areas. Should an institution delivering instruction completely online decide to offer courses or programs physically in the state, the institution must apply to the Coordinating Commission for authorization.

The Nebraska Department of Education oversees private career schools, generally defined as any organization or business enterprise offering instruction for the purpose of training, preparing, or improving the person for an occupation. Your offerings may fall under their jurisdiction. Based on existing statutes and the information provided in your correspondence of April 10, 2014. Monterey Peninsula College of Monterey, California is not required to seek authorization from the Coordinating Commission for Postsecondary Education to offer in Nebraska the courses or programs described in the referenced correspondence.

Dear Senator Liu:

On behalf of the Monterey Peninsula Community College District (MPC), I am pleased to support Assembly Bill 2235 by Assembly Members Joan Buchanan and Curt Hagman. AB 2235 would place a \$9 billion statewide education facilities bond on the 2014 ballot, with \$2 billion being available for community colleges.

MPC is one of the 72 districts within the California community college system that has benefited from previous state bond funds for necessary facility projects that have increased access to higher education for our community. In the past 10 years, \$31.9 million in state funding has been used to upgrade MPC's classroom and support facilities, including renovation of humanities classroom and office buildings, construction of the district's library and technology center, child development facility, and facilities building, and reconfiguration of the former library into administrative offices.

In 2002, the district was successful in passing a \$145 million local bond measure to renew aging campus facilities and infrastructure. As the total cost estimate to complete MPC's facilities plan was over \$200 million, leveraging these local resources with state funding has been a necessary strategy. In addition to the projects mentioned above, MPC has other projects that have been reviewed and approved by the state Chancellor's Office for funding. However, as the last statewide school bond was passed in 2006, state funding for community college projects has been depleted, leaving MPC's projects without a state funding source. To address this situation, MPC was compelled in 2010 to revise its facilities construction plan to downsize the scope and budget of several classroom renovation projects to enable completion using only local funds.

Currently, MPC has two facilities projects approved by the state Chancellor's Office for a 50% state funding match of approximately \$10 million. A new state education facilities bond is essential to completion of these projects as MPC does not have sufficient local funds beyond the local match requirement. One of these projects is the construction of training facilities for MPC's public safety officer programs. As the state's economy recovers and regional police and fire agencies increase hiring, this facility will provide educational opportunity for our students and meet local employment demand for trained public safety officers. In addition, this training facility will be located on the former Fort Ord

and realization of this facility will contribute to the economic development and reuse of the base, an important regional effort and process. The second project needing support from a state bond will modernize campus music instructional facilities constructed over 40 years ago that are in disrepair. The mechanical, plumbing, and electrical systems will be upgraded and improvements made for ADA compliance.

My comments have focused on the value and imminent need for a state bond from MPC's perspective. In addition, a state bond would also address the enormous need for facilities funding at community colleges throughout California. The California Community Colleges Five Year Capital Outlay Plan indicates the entire system requires approximately \$35 billion over the next ten years for construction and modernization. While many community colleges have succeeded in getting local bonds approved to upgrade facilities, the state Chancellor's Office estimates that \$3.2 billion will be needed from a state bond every two years to augment local funds.

The timing of AB 2235 appears to be favorable. We were gratified to see recent polling results that indicate 60% approval for a state educational facilities bond. The voters recognize the bond will provide additional necessary resources that will help MPC and all community colleges to better serve students with modern and effective learning environments. We strongly support AB 2235 and we urge your positive support when the bill is heard in the Senate Education Committee. If you and your staff have any questions, please contact me at (831) 646-4060.

YOUTH FUND GRANT GUIDELINES AND APPLICATION FORM

INTRODUCTION

The Monterey Peninsula Foundation is a nonprofit organization that hosts the AT&T Pebble Beach National Pro-Am golf tournament in Pebble Beach, California and distributes the tournament's proceeds to the community through our grant programs. Since 1937, the Monterey Peninsula Foundation has focused on making a significant contribution to the community.

IMPORTANT INFORMATION FOR GRANT SEEKERS

- 1. *Applications for 2015 Youth Fund Grants are due to the Youth Fund Grant liaison at your college by July 1, 2014. MPC's Youth Fund Grant liaison is Shawn Anderson, Executive Assistant to MPC's Superintendent/President, Dr. Walt Tribley.
- 2. The Youth Fund Grant Committee meets in April, August and November to review applications and make funding decisions.
- 3. Since applicants should expect up to 60-90 days <u>after</u> submitting an application for determination of any funding, applications should be submitted a <u>minimum</u> of 60 days before an applicant hopes a grant application will be reviewed by the Youth Fund Grant Committee.
- 4. Applicants should make every effort to ensure their application is complete only complete applications from eligible organizations will be considered for funding.

GENERAL GUIDELINES

The Monterey Peninsula Foundation Youth Fund is a youth-oriented fund formerly known as the AT&T Pebble Beach National Pro-Am Youth Fund. The Foundation's principal source of funds is the AT&T Pebble Beach National Pro-Am, and the Youth Fund has awarded grants to selected youth-oriented organizations in Monterey, Santa Cruz and San Benito counties since 1954. Approximately 60-70 grants are awarded each year averaging about \$7,500 each; grants range from \$1,000 – 10,000; please note the maximum request amount is \$10,000. Grant applicants must be a tax-exempt, 501 (c) (3) nonprofit organizations as determined by the Internal Revenue Service, or schools. The Youth Fund does not award grants to individuals or for salaries for teachers or school employees. The Youth Fund also requires that organizations submit a completed Grant Outcome Evaluation Report for a grant previously awarded by the Youth Fund or Foundation before a new grant application will be considered. *Grant Outcome Evaluation Reports are due on the date established by your college.

 Nonprofit organizations can apply once in a twelve-month period to <u>either</u> the Youth Fund or the Foundation for a grant, with the exception of public and private schools, colleges and universities

- Public and private schools serving K-12 can apply more than once per year to the Youth Fund
- In general, schools within the same school district cannot be considered for a Youth Fund grant for the same external program
- Colleges and universities may apply separately to the Monterey Peninsula Foundation and the Youth Fund

GRANT APPLICATION TIMING/PROCESS

*Although the Youth Fund Grant Committee reviews grant applications throughout the year, you must meet the application deadlines established by your college. *Applications for 2015 Youth Fund Grants are due to Shawn Anderson, MPC's Executive Assistant to the Superintendent/President, by July 1, 2014. While the Youth Fund only awards grants to nonprofit organizations or schools, we do not request or need copies of the applicant's 501(c)(3) ruling from the IRS that confirms nonprofit status; the Foundation staff confirms the nonprofit status of applicants through its due diligence process.

After a complete (all submitted materials are current and complete according to the directions) grant application is received, the Foundation's Youth Fund Grant Committee considers all applications scheduled for review. Staff may conduct site visits with the applicants or call the applicants with questions. A site visit or call by staff does not guarantee funding approval. If a grant application does not meet the criteria of the Youth Fund, the applicant will be notified immediately. Since applicants should expect up to 60-90 days after submitting an application for determination of any funding, applications should be submitted a minimum of 60 days before an applicant hopes a grant application will be reviewed by the Youth Fund Grant Committee.

SCOPE AND TYPES OF GRANTS

Geographic Funding Areas: Monterey, Santa Cruz and San Benito Counties in California. Types of Grants: the Youth Fund will consider funding requests for the following:

- Special programs at public and charter schools that serve grades K-12
- School equipment for needy youth at private schools that serve grades K-12
- Special programs and/or supplies for youth organizations
- Team uniforms and equipment for boys and girls (K-12) athletic teams (i.e. at schools, or Little League, Pop Warner Football league, etc.)
- Scholarships or financial aid for Monterey County Community Colleges and four-year universities, and limited scholarships for needy students at the K-12 level
- Equipment and supplies for organizations that support mentally and physically challenged children
- Drug or alcohol counseling for youth
- Music and art programs for youth (including youth symphony concerts, youth music festivals, youth theater groups, musical performances geared towards youth, and art classes for youth)
- Instruments, uniforms, and equipment for youth orchestras and bands
- General youth programs
- Early childhood education programs
- Sober Grad Night events (organized by school or PTA)

The Youth Fund does <u>not</u> support salaries for teachers or school employees.

Academic Senate Annual Report

The 2013-2014 Academic Senate Annual Report is ready and has been presented to the board. I urge you to click on this to find more detail.

In bullet point format, some of the things we worked on included:

- Responding to the College Council call for ideas on balancing the budget
- Participating in the review of the Mission Statement
- Collaborating with the ICDE (Institutional Committee on Distance Education) on creating a document describing effective practices for distance education
- Participating in a SWOT (Strengths, Weaknesses, Opportunities, and Threats) analysis of MPC issues from the perspective of academic and professional matters for the accreditation effort
- Providing constructive critique to the Technology Plan
- Promoting collaboration between Student Services and Academic Affairs
- Responding to the accrediting agency's draft revised standards

I'd like to highlight one of these accomplishments.

MPC submitted a recommendation to the accrediting agency about the standards, which are currently being reviewed. Here, in its entirety, is what MPC submitted:

"Standard IIIA6, current draft language:

The evaluation of faculty, academic administrators, and other personnel directly responsible for student learning includes, as a component of that evaluation, consideration of the effectiveness of producing that

learning. Those employees use the results of the assessment of learning outcomes to improve teaching and learning.

"Recommended improvement to Standard IIIA6:

The evaluation of faculty, academic administrators, and other personnel directly responsible for student learning includes, as a component of that evaluation, consideration of how these employees use the results of the assessment of learning outcomes to improve teaching and learning.

"Rationale:

As currently written, Standard IIIA6 implies that certain employees should be evaluated based on how much students learn. There are too many variables that affect student learning to assign the entire responsibility to college employees. What college employees can control is their effort to use assessment results to improve student learning. How employees endeavor to improve student learning is a more appropriate component of an evaluation."

This recommendation originated with the SLO-Accreditation Steering Committee, it was endorsed by the Academic Senate, the College Council, and the Board of Trustees. It was submitted jointly by Walt Tribley and myself on behalf of the institution.

In one of the great surprises of my professional life, the newest draft of these standards, published a few weeks after the deadline for comments, contained the exact language that MPC submitted.

Poetry

Twenty one years ago Bill Clinton was inaugurated for his first term as president. I remember huddling around a small TV with colleagues to watch the inauguration. I really don't remember much of the inauguration, except for one thing. An elderly woman who I had never heard of was the Presidential Poet. Her poem struck me like a corkscrew to the heart. She spoke of rocks, rivers, and trees; of history; and of the interconnectedness of all these things. She spoke about how these symbols of nature are indelible aspects of all of our cultures and how they bind us together. And in the end, in her calm but firm voice evoking a motherly wisdom that makes one stop and listen, she spoke of hope and trust, and the importance of accepting one another.

I read portions of this poem as part of my board report today because it seemed the right thing to do.

Maya Angelou died today. She was 86.

A Rock, A River, A Tree Hosts to species long since departed, Marked the mastodon.

The dinosaur, who left dry tokens
Of their sojourn here
On our planet floor,
Any broad alarm of their hastening doom
Is lost in the gloom of dust and ages.

But today, the Rock cries out to us, clearly, forcefully, Come, you may stand upon my Back and face your distant destiny, But seek no haven in my shadow.

I will give you no more hiding place down here.

You, created only a little lower than The angels, have crouched too long in The bruising darkness, Have lain too long Face down in ignorance.

Your mouths spilling words Armed for slaughter.

The Rock cries out today, you may stand on me, But do not hide your face.

Across the wall of the world, A River sings a beautiful song, Come rest here by my side.

Each of you a bordered country, Delicate and strangely made proud, Yet thrusting perpetually under siege.

Your armed struggles for profit Have left collars of waste upon My shore, currents of debris upon my breast.

Yet, today I call you to my riverside, If you will study war no more. Come,

Clad in peace and I will sing the songs The Creator gave to me when I and the Tree and the stone were one.

Before cynicism was a bloody sear across your Brow and when you yet knew you still Knew nothing.

The River sings and sings on.

There is a true yearning to respond to The singing River and the wise Rock.

So say the Asian, the Hispanic, the Jew
The African and Native American, the Sioux,
The Catholic, the Muslim, the French, the Greek
The Irish, the Rabbi, the Priest, the Sheikh,
The Gay, the Straight, the Preacher,
The privileged, the homeless, the Teacher.
They hear. They all hear
The speaking of the Tree.

Today, the first and last of every Tree Speaks to humankind. Come to me, here beside the River.

Plant yourself beside me, here beside the River.

Each of you, descendant of some passed On traveller, has been paid for.

You, who gave me my first name, you Pawnee, Apache and Seneca, you Cherokee Nation, who rested with me, then Forced on bloody feet, left me to the employment of Other seekers--desperate for gain, Starving for gold.

You, the Turk, the Swede, the German, the Scot ... You the Ashanti, the Yoruba, the Kru, bought Sold, stolen, arriving on a nightmare Praying for a dream.

Here, root yourselves beside me.

I am the Tree planted by the River, Which will not be moved.

I, the Rock, I the River, I the Tree I am yours--your Passages have been paid.

Lift up your faces, you have a piercing need For this bright morning dawning for you.

History, despite its wrenching pain, Cannot be unlived, and if faced With courage, need not be lived again.

Lift up your eyes upon The day breaking for you.

Give birth again To the dream.

Women, children, men, Take it into the palms of your hands.

Mold it into the shape of your most Private need. Sculpt it into The image of your most public self. Lift up your hearts Each new hour holds new chances For new beginnings.

Do not be wedded forever To fear, yoked eternally To brutishness. The horizon leans forward,
Offering you space to place new steps of change.
Here, on the pulse of this fine day
You may have the courage
To look up and out upon me, the
Rock, the River, the Tree, your country.



CSU Monterey Bay graduate overcomes cancer, other obstacles

Kelly Ray "phenomenal" teacher says By Claudia Meléndez Salinas

MONTEREY >> Kelly Ray had always been fascinated with the human body, but her interest increased after suffering two car accidents. Her recovery through yoga and physical therapy made her decide to become a massage therapist.

Ray, 43, began offering her new skills as a volunteer for sporting events, and eventually was invited to offer massage therapy to athletes preparing for the Olympic Games in Greece in 2004. It was an occupation she loved, and she would have continued doing it indefinitely had life not gotten in the way.

Just around the time she found out she was pregnant, Ray's mother was diagnosed with breast cancer — an illness that eventually took her life. Ray herself was later diagnosed with breast cancer. After a few years in remission, she found out last year the disease was back. But throughout her mother's illness and her own, she remained focused on attending college, intent on finishing her bachelor's degree in kinesiology.

Her goal will be accomplished Saturday, when she walks along with another 1,400 students during the CSU Monterey Bay 18th annual commencement ceremony.

"It seems kind of surreal for me," Ray said. "Part of me would like to have my mom there. It's hard to believe the end (of school) is here."

Ray grew up in Monterey and graduated from Monterey High in 1990. She moved to Long Beach a year after graduation to attend Brooks College and pursue a career in fashion design. But the garment industry was not what she expected, so Ray ended up with many other jobs: casino dealer, manager of an athletic club, waitress.

"I always had two to three jobs at a time, but those were the main ones," she said, her 8-year-old son Jay De hanging on her every word.

After becoming a massage therapist, she set a goal to volunteer in as many sporting events as she could: marathons, triathlons, long distance cycling events. She enjoyed being around athletes and helping them improve their performance.

"I love how the body responds and how you can manipulate the muscles," she said. She worked as a volunteer for the International Olympic Committee, so she had the opportunity to work with elite competitors.

"We had great experiences, and (the athletes) are really great people, great kids," she said.

Ray moved back to Monterey after of her mother's cancer. Her plan was to return to sporting events once her child was born.

During her pregnancy and while she was breast-feeding Jay De, Ray was diagnosed with De Quervain's Tendinosis, and she sought job retraining because she would not be able to work as a massage therapist.

Motherhood, a new career, her mother's cancer. It was time to get a check up to help her deal with the stress. It was then when a lump was found on her left breast. It was before her 36th birthday when she was diagnosed with stage 2 breast cancer.

In 2009, on her first year in remission, she decided to enroll in Monterey Peninsula College to pursue a career in physical education. In the fall of 2012, she transferred to CSUMB and enrolled in the kinesiology program.

By then, Ray's mother had moved to Arizona where her husband had retired. Visiting while also going to school was difficult, but Ray managed to keep on top of classes while spending time with her mother, whose cancer was back. Her mother died December 2012.

"That was before finals in my junior year," she said. "The administration and the teachers were very human. They were surprised I was in school the next day, continuing with classes, and ended up passing the semester."

The next semester she hoped she'd be back on her feet, even though it felt strange not having the support of her mother and the comfort her regular phone calls would provide. Then she went for a check up, and the doctors found another lump, this time on her right breast. She had a double mastectomy in the summer and started chemotherapy again in August.

"It's scary," she said. "You think one time . . . is doable. There's a history of cancer in our families, but you don't focus on that, you just live life. I was eating right, I was seeing my acupuncturists and to be diagnosed . . . it was probably more stress related."

Times have been difficult for Ray and Jay De. The boy was very tight with his grandmother, Ray said, so it was very hard losing her. They've received help from counselors to cope with the myriad of changes, the tiredness, the long hours Ray still has to spend in school and studying. What's helped them is their love for each other, the snuggle times and the hugs.

Also, teachers and families at Bay View Academy, where Jay De attends, have rallied around them.

Jessica Guzzi, her son's third grade teacher, "has been amazing," Ray said. "She organized a meal train, she helped edit my papers I had for school. Trying to put sentences together is difficult."

Ray has done a phenomenal job as a student, given her personal circumstances and all the work she completed, said Joanna Morrissey, an assistant professor in the kinesiolgy department.

"This is a challenging time, and she's seen the challenges as obstacles, not as threatening situations," Morrissey said. Among her many qualities, she listed "her sense of responsibility, her sense of professionalism, her ability to communicate to others, always keeping her professors up to date on what was going on her treatment, but never using it as a crutch . . . She's just a phenomenal individual, someone all of our students look up to."

Ray's spirit and endurance is amazing, said friend Elizabeth Nozicka, also a Bay View Academy parent.

"She's been through a lot as a single mom, full-time student, going through this cancer, and she continued to persevere with her studies and her life," Nozicka said. "It's amazing. . . . Now she's graduating and that's really exciting."

Jay De agrees.

"She's amazing," he says of his mother, looking at her with devotion in his eyes.

"Why would you say that?" Ray asks him.

"Because you are," he replies. "Because I love you."

Throughout the ordeal, Ray has remained focused in school because of her son, she says.

"He's my motivation right here," she says. "He's been a true superstar, very supportive. If I need study time or I need to take a nap, he goes off and does what he needs to do and lets me sleep."

For her service learning requirement, Ray gave physical education classes to children at Bay View Academy, and now she hopes to make working with children her new career.

"I want to be more involved with kids, keeping them active, with obesity and health being such a huge issue with kids," she said. "I like to be able to do my part so (children don't) become diagnosed with cancer or other health conditions."

'Skate Jam' helps keep Marina kids on the right road

Investment pays off in big ways for city, competitors By Dennis Taylor

MARINA >> Downhill is usually the best direction to head if you're riding a skateboard, but not if you're living a life, which is why the city of Marina joined forces six years ago with the local Kiwanis Club and Monterey's On The Beach Surf Shop to create a competitive skateboarding team composed mostly of "at-risk" kids.

Those 16 skateboarders spent 230 days on the road in 2010 and 2011, wedged into a van that took them to any city with a skateboarding facility as they competed in the California Amateur Skate League. They surprised everybody, including themselves, by qualifying for the California State Gold Medal Championships, the State Games of America and the National Junior Olympics. Even more stunning was that they won them all.

The cost to the city, the community and local businesses providing sponsorship was \$67,000. With 20-20 hindsight, the payoff has been immeasurable.

"It was worth the money, and you can see that in the camaraderie we have here at our skate park today," said Terry Siegrist, Parks and Recreation director for Marina. "You see it in the vibrancy of the skate program, the number of kids who turn out, and especially in the fact that the kids who started it all are so heavily involved today, not only in events like this one, but also in the leadership of our community."

Siegrist made those comments with pride Saturday as he watched about 50 helmeted youngsters zip around the city's pristine skate park, competing in the On The Beach Skate Jam, a monthly gathering that allows kids to showcase their skateboarding skills for the chance to win close to \$2,000 in prizes — clothing, hats, skateboards, wheels, accessories, shoes, stickers, posters . . .

Skaters pay \$5 to compete at Marina Skatepark, with all of the money going to the Marina Teen Center, a gathering place the city constructed right next door. (On The Beach also sponsors Skate Jams with no entry fee at Monterey Skatepark.)

Posters featuring photographs of that state and national championship team are on display at Marina Skatepark, but, better yet, so are many of those skaters, most of whom are young adults today. They show up regularly to coach and mentor the next generation of skateboarders. They assist with the Skate Jam. They proudly help keep the facility clean.

"I stay involved because of how much I love skateboarding," said 19-year-old Sean Byrne, who was just 16 when he posed with his national champion teammates for the photos on the wall. "Skateboarding has given me so much in life — my closest friends, my best experiences, my biggest opportunities. I mean, skateboarding is the reason I have a job (at On The Beach), and the reason I get to do this."

Byrne serves as the public-address announcer at the Skate Jams, working alongside On The Beach general manager Kyle Goldbeck, who oversees every event.

"We started doing this about six years ago, and it's grown considerably every year," Goldbeck said. "We love to see more and more skaters come out because we're doing this for the kids. I've run every one of these things since the day we began, and I've watched most of these kids grow up."

The Marina Skatepark was a dark and dangerous venue when Siegrist took over as the city's recreation director in 2006. It was a hangout for gang members, a hideout for drug and alcohol abusers, and an ugly, concrete canvas for graffiti artists.

"We had to regain control of the park," Siegrist remembered. "So we refenced it, and then we started working with the local community, and the Kiwanis Club (which provides a free helmet to every Marina skater), and On The Beach. Then we built the Marina Teen Center right next door."

The teen center not only evolved into a hot spot for Marina's youth — about 100 have breakfast there every morning, and another 300 to 400 show up each afternoon — but also enabled the city to keep a closer watch on its skating facility. Not only are adults present to supervise, but multiple cameras have been installed, enabling Marina police to monitor activity from their squad cars. The result is a safe haven.

Siegrist became the manager of the On The Beach Skate Team, driving the future champions to every event, supervising them in hotels, overseeing their preparation for upcoming competitions.

"It all started as an opportunity to get those high-risk kids involved in something," he said. "When we began, there seemed to be very little potential for any of them to become what they've become: Today they're high school athletes or college students."

"It changed my whole life," said 19-year-old Andrew Love, a member of the 2011 championship team who now studies music theory at Monterey Peninsula College and makes his living playing in a band, "The Healing."

"Skating has always been a way for me to express myself," Love added. "And it's always provided me with a way to get away from whatever was bothering me, whatever was affecting me in my life."

Alejandro Martinez, a 13-year-old on that 2010-11 title team, is now a 16-year-old basketball player at Marina High.

"I used to skate every day, and I don't anymore," he said. "I just got burned out, got tired—it wasn't fun anymore. I've never broken a bone, but I was getting banged up.

"But I'm starting to get back into it," he said. "I missed it, I guess, and I just love being out here."

The next On The Beach Skate Jams are scheduled June 14 in Monterey and Sept. 13 in Marina, with a championship meet on Oct. 18 at the Marina facility. More information can be obtained by contacting On The Beach Surf Shop at 646-9283.

Kirby Scudder: Arts Habitat brings the creative arts to Fort Ord

Fort Ord in Monterey was purchased in 1917 for use as an artillery training field for the U.S. Army. Formerly the area was known as the Gigling Reservation. In 1933, the artillery field was named Camp Ord, after Maj. Gen. Edward Ord. In 1940, Camp Ord was expanded to 2,000 acres and redesignated as Fort Ord and until the 1970s was the primary facility for basic training for the Army. Fort Ord closed in 1994 and much of the old military buildings and infrastructure remain abandoned, while other structures have been torn down for anticipated development.

In 1991, a group of local artists heard that the base was closing and petitioned the Monterey County Board of Supervisors to include an arts district in the reuse program on the property. The group formed Arts Habitat, a nonprofit organization dedicated to the creation of an affordable arts community at East Garrison on the East side of the base. The project would generate income for artists and create economic development for the county. In 2007, the East Garrison project broke ground. Construction proceeded until the economic downturn, which caused building to stop in the summer of 2008. After several setbacks, last year saw the completion of housing completed at Manzanita Place and continued momentum with the development of the property.

Along with their ongoing efforts at Fort Ord, Arts Habitat runs a series of arts programs. Since 2009, it has hosted the popular Arts in Progress, a program that encourages participation and appreciation of art. It also provides a gathering spot for artists and art enthusiasts to build collaborations through networking. On Tuesday, Arts in Progress presents artist Lance Brown's presentation titled "Through the Artistic Eye" at the Museum of Monterey.

The newest program is premiering with "This Business Called Art," a panel discussion cohosted by Arts Habitat, the Carmel Art Association and the Monterey Museum of Art. The event will be held at the Monterey Museum of Art on June 11. The three speakers are Nina Simon, executive director of Santa Cruz's Museum of Art and History; Chris Winfield, owner, Winfield Gallery in Carmel; and photographer Huntington Witherill. It will be moderated by Charlotte Eyerman, executive director of the Monterey Museum of Art. The evening is directed at the needs of visual artists who are interested in the business side of art.

I spoke with Arts Habitat administrator Shirmaine Jones about "This Business Called Art" and Fort Ord.

KIRBY SCUDDER >> How did the panel discussion "This Business Called Art" come to be?

SHIRMAINE JONES >> We are interested in ways of helping local artists and it is part of our ongoing mission to collaborate with other organizations. Working with Charlotte Eyerman allows us to partner with the Monterey Museum of Art. Along with the panel discussion, we are offering several workshops that will go into more depth about the business of art. At the panel discussion we will be looking to get feedback from artists about what areas they are interested in exploring in the workshops, which allows us to cater to the needs of the local art community. So as an example marketing will be covered in the panel discussion, but a three-hour workshop will allow us to go into much greater detail about how to use your website and social media to promote your work. We have already surveyed over 100 artists to find out what subjects are most important to them.

KIRBY SCUDDER >> What is the status of your work at Fort Ord?

SHIRMAINE JONES >> After a series of delays due to the economy, it is finally happening as of last year. There is a low-income housing building completed called Manzanita Place and that was built through the local HUD agency. It has 66 units of affordable housing. That has been built and occupied since September of last year. We now have the first phase of individual homes being built and sold as well. That's the project that got us started. And because it has and is taking a while for Arts Habitat to have a permanent location there we have developed ongoing programs to support new and emerging artists. The first of those programs was called "Houses Art" and it was a collaboration over several years with the local colleges MPC (Monterey Peninsula College) and Hartnell, and Monterey High School where artists got together and worked on very large canvasses shaped like houses.
