## **Discussion Agenda**

Visiting Business Department Faculty: Jon Mikkelsen and Bruce Barrie

Bruce Barrie provided an overview of proposals in CurricUNET that he has created and that have been in the pipeline for a while. Bruce presented the rationale for the course BUSI 46, Entrepreneural Mindset, which was launched in 4/21/17 as a new course proposal. This course has made it through Tech Review and is now at the Dean of Instructional Planning level for approval.

Bruce presented the rationale for BUSI 68, Entrepreneural Start-up Ventures, as a capstone class that "cuts across all of our CTE programs" and provides a lecture/lab class where students can explore entrepreneurship in any discipline. This course has made it through Tech Review and is now at the Dean of Instructional Planning level. Bruce hopes that both courses can make it into the Fall 2018 catalog for approval.

Jon Mikkelsen offered to provide clarification or answer questions regarding the proposed changes to the Business course SLOs. The group engaged in conversation about the appropriateness of combining multiple SLOs into a single SLO for a course. Jon M offered alternate approaches to analyzing student performance based on the single SLO using grade trends and other student performance data that was informed by conversations with Rosaleen Ryan in the Office of Institutional Research. The group discussed the concern of the possibility of using grades in place of assessing SLOs. Jon clarified that this was not the intent but instead to streamline the process and make more consistent so that it can be better managed by the many adjuncts in the BUSI program.
