Academic Affairs Report Presented by Kiran Kamath, VPAA

1. Enrollment Update:

As a college, we are working collaboratively to schedule more effectively. The Enrollment Management System (EMS) is providing historical and trend data from previous semesters to make better scheduling decisions. We are actively using EMS data to make future scheduling decisions.

MPC's FTES target for the 2017 -18 academic year is as follows:

Fall 2017	2700
Spring 2018	2700
Summer 2018	800
South Bay (2017-18)	625

The goal is to achieve this target FTES at a college-wide average productivity of 14.0 or higher.

MPC Fall enrollment:

Fall 2017 Full Time Equivalent Students (FTES) and productivity data has improved compared to Fall 2016. It includes all enrollment - Monterey campus, Marina campus, PSTC, CSUMB ACE, and High School Dual Enrollment. It excludes South Bay ISAs.

Late Start Classes:

The College will again offer "Late Start" classes beginning mid-October (the week of October 16). This will enable students who missed enrolling in August to enroll in Late Start classes and become "Continuing Students" in Spring 2018. As Continuing Students, they will be able to enroll for classes earlier than "New Students" in Spring 2018.

2. Curriculum and Assessment Update:

Progress continues to be made towards reaching our goal of assessing all our courses by December 2017. We will need to now also make some progress on assessing our programs.
