Discussion MPC GE:

• BIOL 30

- o It was brought to CAC's attention that MPC GE Standards do not list lab as a requirement for Area B, but the MPC GE page in the 2018-2019 Catalogue does
- o GM is going to contact Jon Knolle in order to find out the source for this requirement, as no one on the committee could recollect a specific date or rationale behind its assignment.
- Regarding Area E for BIOL 30, CAC suggested revisions to both the outcomes and objectives, specifically incorporating 'wellness' language.

ENSL 10

- The issue for the department is procedural the department wants to combine ENSL 155 and ENSL 110, and ultimately seek approval for GE Area C.
- o The department's question was whether this proposal should be considered a new course or a revised course, and they had hoped to use the original course number for ENSL 110, which was ENSL 10.
- o CAC noted that ENSL 10 cannot be used as a number for a new course, as it already exists in the system.
- o The discussion offered two possible routes: the department can delete ENSL 110 and 155, then create a new course or they can take either ENSL 110 or 155, revise it and then delete the other.
- o GM has been in contact with Molly May on this, and departmental discussions regarding the options are ongoing.
