Discussion Agenda

Update to Resource Guide to Institutional Decision Making: Review of CAC information

Additional discussion about the Resource Guide included the current CAC reporting structure as it is and if that falls within the parameters of Title 5. Our documentation shows that we report directly to the President and Board, but Title 5 suggests we should report to the Academic Senate. CAC is associated with the Academic Senate as they confirm the appointments to all committees including CAC. There is documentation from many years ago of the Senate deferring authority on curriculum to CAC. That documentation will be found and brought to the committee at a future meeting.
