## Parent (PLUS) Loan for Undergraduate Student Application

### Eligibility

To qualify for Federal Parent PLUS Loan you must:

- ⇒ Cannot be in default on any type of Federal Loan.
- ⇒ Be a U.S. citizen or eligible non-citizen.
- ⇒ Apply for an FSA ID at <https://studentaid.gov/fsa-id/create-account/launch>
- ⇒ Student completes 2023-2024 Free Application for Federal Student Aid (FAFSA) <https://studentaid.gov/h/apply-for-aid/fafsa>
- ⇒ Pass a credit check conducted by the loan servicing agency. A Parent PLUS loan applicant who is determined to have an adverse credit history may receive the loan if he or she obtains a co-signer for the loan who passes the credit check.

### Application Process

1. Submit a 2023-2024 Parent PLUS Loan Application to the MPC Student Financial Services Office.
2. Go to <https://studentaid.gov/> Log In=> Loans & Grants => **PLUS Loans: Grad PLUS & Parent Plus** => **"I am a Parent of a Student"** => **START** Follow the instructions provided.
3. Go to <https://studentaid.gov/> Click on the "Loans & Grants" => **"MPN"** => **I'm a Parent of an Undergraduate Student** => **START** Follow the instructions provided.
4. At any time you can request to adjust your Parent Plus Loan amount from our MPC Student Financial Services Office.
5. The interest rate for the 2023-2024 year is **8.05%**.
6. An origination fee of 4.228% will be deducted from each disbursement.
7. **NO Summer Loans** *Form Deadline May 2, 2024*
