Discussion

A discussion was had regarding membership of the CAC committee. Glenn wanted to know why we were Reconsidering ARC representation. Carrie confirmed that there were only three faculty in that area, and a suggestion was made to offer participation in CAC as an At-Large Student Services Representative, to expand the faculty pool.

Jon Knolle talked about AP 4022 and AP 4023. A suggestion was made to extend the program revision deadline to November 1st. It was suggested that we open up courses for changes as early as March, though it was determined that we would have to wait until the catalog was locked into its final form before doing so. It was discussed that the curriculum institute recommended to not cross-list courses anymore, so we may wish to remove references to cross-listing from these documents. Jon also noted that CAC will need to review the Graduation Requirements AP, as Ethnic Studies needs to be incorporated.
