The committee felt the course outline needed to be revised for clarity and that, as currently written, the lab content is too broad. Sunshine will contact the department to clarify that drop statements belong in comments, not course descriptions; to ask for an explanation of the A-B-C-D number sequence and repeatability; and, to ask that the course outline language be revised for clarity.
