Consideration of this course was tabled last week pending the addition of statement regarding the limit of one English course below transfer level applying towards the associate degree.  During committee discussion it was determined that ENGL 1A will have to be revised to include prerequisites of both ENGL 111 and ENGL 112. Until such a requirement has been added to ENGL 1A, it is premature to revise the course descriptions for ENGL 111 and ENGL 112 to include a statement regarding the limit of one English course below transfer level applying towards the associate degree.
